**THE WIGAN BOROUGH (DECriminalISATION OF PARKING)
(WIGAN ROADS NO. 2) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004
(AMENDMENT NO. 22) ORDER 2008**

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order -

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 22) Order 2008 and shall come into operation on 25th August 2008
2. The Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2) (Traffic Regulation Consolidation) Order 2004 is hereby further amended as follows:-
 - (a) In relation to Schedule One, the following entries shall be deleted from Schedule One to the Order:-

Worsley Mesnes Drive, Wigan	Both	A point 15 metres south west of Tyrer Avenue	A point 63 metres north west of Mesnes Avenue
-----------------------------	------	--	---

Worsley Mesnes Drive, Wigan	South	Its junction with Poolstock Lane	A point 63 metres north west of Mesnes Avenue
-----------------------------	-------	----------------------------------	---

Tyrer Avenue, Wigan	Both	Its junction with Worsley Mesnes Drive	For a distance of 11 metres in a north westerly direction
---------------------	------	--	---

Tyrer Avenue, Wigan	West	A point 11 metres north west of Worsley Mesnes Drive	For a distance of 24 metres in a north westerly direction
---------------------	------	--	---

- (b) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Dryden Close, Wigan	Both	Its junction with Worsley Mesnes Drive	For a distance of 5 metres in a southerly direction
---------------------	------	--	---

Worsley Mesnes Drive, Wigan	North	A point 15 metres south of Tyrer Avenue	A point 64 metres north of Mesnes Avenue
-----------------------------	-------	---	--

Worsley Mesnes Drive, Wigan	South	Its junction with Poolstock Lane	A point 15 metres south of Tyrer Avenue
Tyrer Avenue, Wigan	East	Its junction with Worsley Mesnes Drive	For a distance of 15 metres in a northerly direction
Tyrer Avenue, Wigan	East	Its junction with Worsley Mesnes Drive	For a distance of 40 metres in a northerly direction

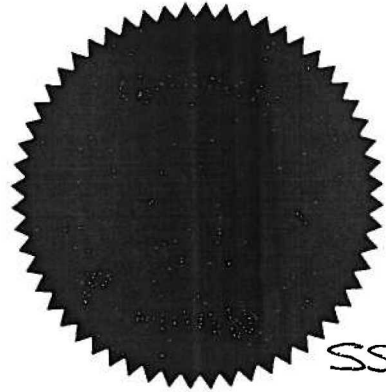
