THE WIGAN BOROUGH(DECRIMINALISATION OF PARKING) (VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO. 123) ORDER 2008

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order -

- This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 123) Order 2008 and shall come into operation on 21st July 2008
- 2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 is hereby further amended as follows:-
 - (a) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-
