(VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION)
ORDER 2004 (AMENDMENT NO. 123) ORDER 2008

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order -

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 123) Order 2008 and shall come into operation on 21st July 2008
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 is hereby further amended as follows:-

- (a) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Peter Street, Golborne	West	a point 10 metres north of its junction with Barn Lane	its junction with Talbot Street

Barn Lane, Golborne	Both	its junction with Peter Street	for a distance of 10 metres in a westerly direction
---------------------	------	--------------------------------	---

Talbot Street, Golborne	South	its junction with Peter Street	for a distance of 15 metres in an easterly direction

- (b) In relation to Schedule Two the following entry shall be deleted from Schedule Two to the Order:

Peter Street, Golborne	West	its junction with Heath Street	its junction with Barn Lane	on any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8:00am to 6:00pm

- (c) In relation to Schedule Two the following entries shall be added to Schedule Two to the Order:

Peter Street, Golborne	West	its junction with Heath	a point 10 metres north of its junction with Barn Lane	on any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8:00am to 6:00pm
------------------------	------	-------------------------	--	--

Turton Street, Golborne	West	a point 38 metres south of its junction with Talbot Street	its southerly end	on any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8:00am to 6:00pm
-------------------------	------	--	-------------------	--

(d) In relation to Schedule 9 the following entry shall be deleted from Schedule 9 to the Order:

Peter Street, Golborne	West	a point 38 metres south of its junction with Talbot Street	its southerly end.

(e) In relation to Schedule 9 the following entry shall be added to Schedule 9 to the Order:

Talbot Street, Golborne	South	a point 68 metres west of its junction with Turton Street	for a distance of 43.56 metres in a westerly direction

3. Save as provided in relation to the above amendments. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 shall remain in force.
