Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

- This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 129) Order 2008 and shall come into operation on 12th August 2008.
- 2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-
 - (a) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Edgeworth Road, Golborne	Both	Its junction with Harvey Lane	For a distance of 10 metres in a northerly direction
Harvey Lane, Golborne	North	A point 10 metres west of its junction with Millstone Court	A point 10 metres east of its junction with Millstone Court
Harvey Lane, Golborne	North	A point 10 metres west of its junction with Whitlow Avenue	A point 10 metres east of its junction with Whitlow Avenue
Harvey Lane, Golborne	South	A point 29 metres west of the westerly kerbline of Whitlow Avenue	For a distance of 32 metres in a westerly direction
Harvey Lane, Golborne	North	A point 10 metres west of its junction with Edgeworth Road	A point 10 metres east of its junction with Edgeworth Road
Harvey Lane, Golborne	North	A point 10 metres west of its junction with Helen Street	A point 10 metres east of its junction with Helen Street
Harvey Lane, Golborne	North	Its junction with Sandy Lane	For a distance of 30 metres in an easterly direction
Helen Street, Golborne	Both	Its junction with Harvey Lane	For a distance of 10 metres in a northerly direction

Whitlow Avenue, Golborne	Both	Its junction with Harvey Lane	For a distance of 10 metres in a northerly direction
