**WIGAN BOROUGH (DECRIMINALISATION OF PARKING)**  
**(VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION)**  
**ORDER 2004 (AMENDMENT NO.131) ORDER 2008**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No.131) Order 2008 and shall come into operation on 11<sup>th</sup> August 2008.
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-

(b) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Broomfield Road, Standish	Both	Its junction with Avondale Street	A distance of 15 metres in a southerly direction.

Avondale Street, Standish	South	A point 20 metres west of its junction with Broomfield Road	its junction with Bradley Lane (leading to Ormsby Close)

Avondale Street, Standish	North	A point 10 metres west of its junction with Dovedale Drive	A point 10 metres east of its junction with Dovedale Drive

Bradley Lane, Standish	South	Its junction with Bradley Lane (leading to Ormsby Close)	For a distance of 10 metres in an easterly direction

Bradley Lane (leading to Ormsby Close), Standish	Both	Its junction with Bradley Lane	For a distance of 10 metres in an southerly direction

Dovedale Drive, Standish	Both	Its junction with Bradley Lane	For a distance of 10 metres in an northerly direction

3. Save as provided in relation to the above amendments The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 as amended shall remain in force.
