**WIGAN BOROUGH(DECriminalISATION OF PARKING)
(VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION)
ORDER 2004 (AMENDMENT NO. 133) ORDER 2008**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order-

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 133) Order 2008 and shall come into operation on 1st September 2008
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 is hereby further amended as follows:-
 - (a) In relation to Schedule One, the following entries shall be deleted from Schedule One to the Order:-

Stamford Street, Atherton	West	its junction with Bolton Road	for a distance of 15 metres in a southerly direction

- (c) In relation to Schedule Two the following entries shall be deleted from Schedule Two to the Order:-

Bolton Road, Atherton	South	a point 43 metres west of its junction with Stamford Street	a point 15 metres west of its junction with Douglas Street	on any day 7:30am – 9:30pm and 4:00pm to 6:30pm

Bolton Road, Atherton	North	a point 23 metres west of its junction with Stamford Street	A point 15 metres east of its junction with Stamford Street	On any day 7:30am – 9:30pm and 4:00pm to 6:30pm

(d) In relation to Schedule Two the following entry shall be added to Schedule Two to the Order:-

Bolton Road, Atherton	North	A point 15 metres east of its junction with Stamford Street	A point 40 metres east of its junction with Douglas Street	on any day 7:00am – 10:00am and 4:00pm – 7:00pm

(e) In relation to Schedule Four the following entries shall be added to Schedule Four to the Order:-

Bolton Road, Atherton	North	its junction with Upton Road	for a distance of 46 metres in a westerly direction	on any day 7:00am – 10:00am and 4:00pm – 7:00pm

Bolton Road, Atherton	South	a point 15 metres west of its junction with Douglas Street	a point 40 metres east of its junction with Douglas Street	on any day 7:00am – 10:00am and 4:00pm – 7:00pm

Upton Road, Atherton	Both	its junction with Bolton Road	for a distance of 48 metres in a northerly direction	on any day 7:00am – 10:00am and 4:00pm – 7:00pm

Douglas Street, Atherton	Both	its junction with Bolton Road	for a distance of 15 metres in a southerly direction	on any day 7:00am – 10:00am and 4:00pm – 7:00pm

3. Save as provided in relation to the above amendments the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 shall remain in force.

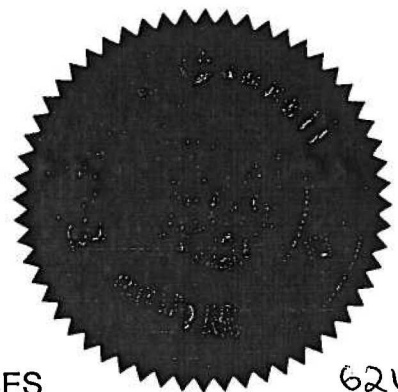
