(AMENDMENT NO. 37) ORDER 2008**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 37) Order 2008 and shall come into operation on 1st November 2008.
2. Wigan Borough (Decriminalisation of Parking) (Wigan Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, the following entries shall be deleted from Schedule One to the Order:-

New Market Street, Wigan	South east	Its junction with Market Street	A point 62 metres north east of its junction with Market Street
