ORDER 2004 (AMENDMENT NO.125) ORDER 2008**

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order -

1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 125) Order 2008 and shall come into operation on the 10th November 2008 .
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Caldwell Avenue, Astley	Both	Its junction with Manchester Road	For a distance of 10 metres in an easterly direction
Lingards Lane, Astley	East	Its junction with Manchester Road	For a distance of 10 metres in a southerly direction
Lingards Lane, Astley	West	Its junction with Manchester Road	For a distance of 18 metres in a southerly direction
Manchester Road, Astley	South	A point 24 metres east of its junction with Caldwell Avenue	A point 38 metres west of its junction with Lingards Lane
Manchester Road, Astley	North	A point 15 metres west of its junction with Hope Street	A point 38 metres west of its junction with Lingards Lane
Manchester Road Service Road, Astley (servicing Abbots Green and Sandy Lane)	South	Its northerly junction with Manchester Road	For a distance of 10 metres in a southerly direction

Manchester Road Service Road, Astley (servicing Abbots Green and Sandy Lane)	North	Its easterly junction with Manchester Road	Its westerly junction with Manchester Road

Manchester Road Service Road, Astley (servicing Abbots Green and Sandy Lane)	South	Its southerly junction with Manchester Road	For a distance of 13 metres in an easterly direction


