**WIGAN BOROUGH(DECriminalISATION OF PARKING)
(LEIGH ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004
(AMENDMENT NO.30) ORDER 2008**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.30) Order 2008 and shall come into operation on 12th December 2008.
2. Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Kirkhall Lane, Leigh	North	A point 18 metres west of its junction with Byrom Street	A point 10 metres east of its junction with Byrom Street
Byrom Street, Leigh	Both	Its junction with Kirkhall Lane	A distance of 10 metres in a northerly direction
Kirkhall Lane, Leigh	North	A point 10 metres west of its junction with Newall Grove	A point 10 metres east of its junction with Newall Grove
Newall Grove, Leigh	Both	Its junction with Kirkhall Lane	A distance of 10 metres in a northerly direction
Kirkhall Lane, Leigh	North	A point 10 metres west of its junction with Cavendish Street	Its junction with Cavendish Street
Cavendish Street, Leigh	Both	Its junction with Kirkhall Lane	A distance of 10 metres in a northerly direction

Kirkhall Lane, Leigh	South	A point 10 metres west of its junction with Glebe Street	A point 10 metres east of its junction with Glebe Street

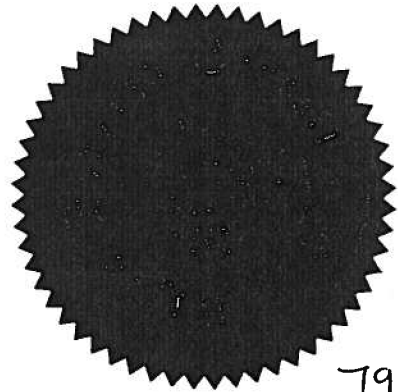
