## **WIGAN BOROUGH COUNCIL**

## THE WIGAN BOROUGH (VARIOUS ROADS, WIGAN TOWN CENTRE) (PROHIBITION OF DRIVING) ORDER 2008

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984, hereby makes the following Order -

- This Order may be cited as the Wigan Borough (Various Roads, Wigan Town Centre) (Prohibition of Driving) Order 2008 and shall come into operation on 5<sup>th</sup> January 2009.
- 2. (1) In this Order -
  - "specified" means specified in the Schedule to this Order.
  - (2) A reference in this Order to a numbered Article is a reference to the Article having that number in this Order.
  - (3) The Interpretation Act 1978 applies for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. No person shall except upon the direction or with the permission of a police constable in uniform or of a Police Community Support Officer cause or permit a vehicle to enter, proceed or wait in the length of road specified in Schedule 1 to this Order
- 4. No person shall except upon the direction or with the permission of a police constable in uniform or of a Police Community Support Officer cause or permit a vehicle to enter, proceed or wait in the lengths of road specified in Schedule 2 to this Order.
  - (1) save as provided in paragraphs (2) and (3)
  - (2) it shall not be unlawful to drive a motor vehicle, or cause or permit a motor vehicle to be driven in the lengths of road specified in Schedule 2 to the Order-
    - (a) solely for the purpose of enabling the vehicle to be used in the delivery or collection of goods or to be loaded or unloaded between the hours of 4:00pm and midnight.
    - (b) so as to enable the vehicle -
      - (i) if it cannot conveniently be used for such purpose in any such road, to be used in or in connection with building, engineering or demolition operations, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the specified lengths of road, or the laying, , erection, alteration or repair in, or in land adjacent to, such lengths of the specified roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telegraphic line as defined in the Telecommunications Act 1984,
      - (ii) to be used for fire service, ambulance or police purposes; or

- 5. No person shall except upon the direction or with the permission of a police constable in uniform or of a Police Community Support Officer cause or permit a vehicle to enter, proceed or wait in the lengths of road specified in Schedule 3 to this Order.
  - (1) save as provided in paragraphs (2) and (3)
  - (2) it shall not be unlawful to drive a motor vehicle, or cause or permit a motor vehicle to be driven in the lengths of road specified in Schedule 3 to the Order-
    - (a) solely for the purpose of enabling the vehicle to be used in the delivery or collection of goods or to be loaded or unloaded between the hours of 4:00pm and midnight.
    - (b) so as to enable the vehicle -
      - (i) if it cannot conveniently be used for such purpose in any such road, to be used in or in connection with building, engineering or demolition operations, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the specified lengths of road, or the laying, , erection, alteration or repair in, or in land adjacent to, such lengths of the specified roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telegraphic line as defined in the Telecommunications Act 1984,
      - (ii) to be used for fire service, ambulance or police purposes; or
  - (3) it shall not be unlawful to drive an official vehicle, or cause or permit an official vehicle to be driven on the lengths of road specified in Schedule 2 to the Order in connection with weddings or funerals at the Queen Hall Methodist Mission
- 6. Article 5(i) of the Wigan Borough (Wigan Town Centre) (Miscellaneous Provisions) Order 1990 (Amendment) Order 1996 is hereby revoked
- 7. Article 3(i) of the Wigan Borough (Market Place and Market Street, Wigan) (Traffic Scheme) Order 1993 is hereby revoked
- 8. Article 3 of the Wigan Borough (Hallgate, Wigan) (Prohibition of Driving) Order 1993 is hereby revoked
- 9. The Prohibition of Driving on Market Place from Library Street for a distance of 20 metres in a northerly direction introduced by the Wigan Borough (Standishgate, Market Place and Market Street, Wigan) (Prohibition of Driving) Order is hereby revoked


