**WIGAN BOROUGH(DECriminalISATION OF PARKING)
(WIGAN ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004
(AMENDMENT NO. 41) ORDER 2009**

Wigan Borough Council, in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 47 and 49 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other powers enabling it in that behalf, hereby makes the following Order -

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 41) Order 2009 and shall come into operation on 23 January 2009.
2. The Wigan Borough (Decriminalisation of Parking) (Wigan Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule Two, the following entries shall be deleted from Schedule Two to the Order:-

<i>ROAD</i>	<i>SIDE</i>	<i>FROM</i>	<i>TO</i>	<i>PERIOD OF OPERATION</i>
Bishopgate	north east	a point 28m south of its junction with Hallgate	its junction with Crawford Street	on any day 8:00 am – 5:30 pm
Crawford Street	south east	a point 6m northeast of its junction with King Street West	the cul-de-sac end, including both sides of the cul-de-sac end	on any day 8:00am – 5:30pm

- (b) In relation to Schedule Two, the following entries shall be added to Schedule Two to the Order:-

<i>ROAD</i>	<i>SIDE</i>	<i>FROM</i>	<i>TO</i>	<i>PERIOD OF OPERATION</i>
Bishopgate	north east	a point 18m south of its junction with Hallgate, for a distance of 13m in a southerly direction	a point 31m south of its junction with Hallgate	on any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8:00am – 5:30pm

Crawford Street	south east	its junction with Bishopgate, excluding its cul-de-sac end	a point 6m east of its junction with King Street West	on any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8:00am – 5:30pm

(c) In relation to Schedule Five, the following entry shall be added to Schedule Five to the Order:-

ROAD	SIDE	FROM	TO	PERIOD OF OPERATION
Bishopgate	north east	a point 3m south of its junction with Hallgate, for a distance of 15m in a southerly direction	a point 18m south of its junction with Hallgate	at any time

(d) In relation to Schedule Seven, the following entries shall be added to Schedule Seven to the Order:-

ROAD	SIDE	FROM	TO	PERMITTED HOURS
Bishopgate	north east	a point 31m south of Hallgate	its junction with Crawford Street	on any day 9:00am – 5:00pm
Crawford Street	east	its junction with Bishopgate	its cul-de-sac end, including the length of each side of the cul-de-sac end	on any day 9:00am – 5:00pm

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Wigan Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
