(VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION)
ORDER 2004
(AMENDMENT NO.144) ORDER 2009

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No.144) Order 2009 and shall come into operation on 26th February 2009.
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, the following entry shall be deleted from Schedule One to the Order:-

Bolton Road, Aspull	East	A point 15 metres south east of the unnamed link road, opposite Aspull Church Primary School	A point 15 metres north west of the unnamed link road, opposite Aspull Church Primary School

- (b) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Bolton Road, Aspull	East	A point 53 metres north west of the unnamed link road, opposite Aspull Church Primary School	A point 288 metres south east of the unnamed link road, opposite Aspull Church Primary School

Bolton Road, Aspull	West	A point 26 metres north west of the unnamed link road, opposite Aspull Church Primary School	For a distance of 21 metres in a north westerly direction

Bolton Road, Aspull	West	A point 15 metres south east of its junction with The Fields	A point 15 metres north west of its junction with The Fields
---------------------	------	--	--

The Fields, Aspull	Both	Its junction with Bolton Road	For a distance of 10 metres in a southerly direction

Unnamed link road, opposite number 41 Bolton Road, Aspull	Both	Its junction with Bolton Road	For a distance of 15 metres in a northerly direction

(b) In relation to Schedule Two, the following entries shall be added to Schedule Two to the Order:-

Bolton Road, Aspull	West	From a point 15 metres north west of its junction with The Fields	For a distance of 177 metres in a north westerly direction	On any Monday, Tuesday, Wednesday, Thursday, Friday 8.00am- 5.00pm

3. Save as provided in relation to the above amendments The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
