(VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION)
ORDER 2004
(AMENDMENT NO.165) ORDER 2009

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order-

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No.165) Order 2009 and shall come into operation on *22 June 09*.
2. Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule Two, the following entry/entries shall be deleted from Schedule Two to the Order:-

Manchester Road, Tyldesley	North	A point 52 metres east of its junction with Peel Hall Avenue	A point 23 metres east of its junction with Common Lane	On any Monday, Tuesday, Wednesday, Thursday, Friday and Saturday 8.00am – 6.00pm

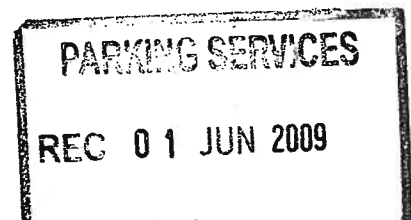
- (b) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Manchester Road, Tyldesley	North	A point 40 metres west of its junction with Peel Hall Avenue	A point 52 metres east of its junction with Peel Hall Avenue

Peel Hall Avenue, Tyldesley	Both	Its junction with Manchester Road	A point 10 metres west of its junction with Brackley Avenue

Brackley Avenue, Tyldesley	Both	Its junction with Peel Hall Avenue	A point 10 metres east of its junction with Peel Hall Avenue

- (c) In relation to Schedule Two, the following entries shall be added to Schedule Two to the Order:-




Manchester Road, Tyldesley	North	A point 40 metres west of its junction with Peel Hall Avenue	A point 23 metres east of its junction with Common Lane	On any Monday, Tuesday, Wednesday, Thursday, Friday and Saturday 8.00am – 6.00pm

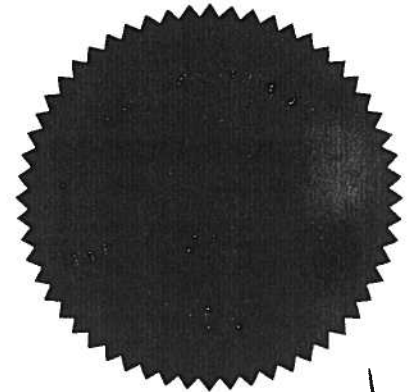
