THE WIGAN BOROUGH COUNCIL (DISABLED PERSONS PARKING SPACES)  
(AMENDMENT TO CONSOLIDATION ORDERS) ORDER 2009

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order:-

1. This Order may be cited as The Wigan Borough Council (Disabled Persons Parking Spaces) (Amendment to Consolidation Orders) Order 2009 and shall come into operation on 5<sup>th</sup> May 2009.
2. The following Articles hereby replace Articles 72, 73 and 74 of The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004, The Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 and The Wigan Borough (Decriminalisation of Parking) (Wigan Roads No 2) (Traffic Regulation Consolidation) Order 2004:-

72. Save as provided in Article 73, no person shall except upon the direction or with the permission of a police constable in uniform or of a police community support officer in uniform cause or permit a vehicle to wait during the period of operation specified in column 5 of Schedule 10 on the sides or lengths of road specified in columns 1 to 4 of Schedule 10.

73. It is not unlawful to cause or permit a vehicle to wait at any time on the sides and lengths of road specified in columns 1 to 4 of Schedule 10 during the period of operation specified in column 5 of Schedule 10 provided.

- a) the vehicle displays a disabled person's badge and a parking disc in the relevant position; and
- b) the quarter-hour period during which the period of waiting commenced is marked on the parking disc;

74. It is not unlawful to cause or permit a vehicle to wait on the sides and lengths of road specified in columns 1 to 4 in Schedule 10 for so long as may be necessary to enable:-

- a) the laying, erection, alteration or repair in, or in land adjacent to, such length of road or any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telecommunications Act 1984;
- b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or a water company in pursuance of statutory powers or duties;
- c) the vehicle to be used for fire services, ambulance or police purposes or in connection with a funeral provided that the vehicle being used for fire service, ambulance or police purposes is a liveried vehicle;

3. The following Articles hereby replace Articles 80, 81 and 82 of The Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004.

80. Save as provided in Article 81, no person shall except upon the direction or with the permission of a police constable in uniform or of a police community support officer in uniform cause or permit a vehicle to wait during the period of operation specified in column 5 of Schedule 10 on the sides or lengths of road specified in columns 1 to 4 of Schedule 10.

81. It is not unlawful to cause or permit a vehicle to wait at any time on the sides and lengths of road specified in columns 1 to 4 of Schedule 10 during the period of operation specified in column 5 of Schedule 10 provided.

- a) the vehicle displays a disabled person's badge and a parking disc in the relevant position; and
- b) the quarter-hour period during which the period of waiting commenced is marked on the parking disc;

82. It is not unlawful to cause or permit a vehicle to wait on the sides and lengths of road specified in columns 1 to 4 in Schedule 10 for so long as may be necessary to enable:-

- a) the laying, erection, alteration or repair in, or in land adjacent to, such length of road or any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telecommunications Act 1984;
- b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or a water company in pursuance of statutory powers or duties;
- c) the vehicle to be used for fire services, ambulance or police purposes or in connection with a funeral provided that the vehicle being used for fire service, ambulance or police purposes is a liveried vehicle;
