(AMENDMENT NO.167) ORDER 2009

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No.167) Order 2009 and shall come into operation on 24th July 2009.
2. Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-

- (a) In relation to Schedule Seven, the following entry/entries shall be deleted from Schedule Seven to the Order:-

Milton Grove, Wigan	West	a point 9 metres north of its junction with Tennyson Drive	a point 7 metres south of its junction with Wigan Lane	on any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00am until 5.00pm
Milton Grove, Wigan	West	a point 10 metres south of its junction with Tennyson Drive	a point 23 metres west of its junction with Wordsworth Avenue	on any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00am until 5.00pm

- (b) In relation to Schedule Two, the following entry/entries shall be deleted from Schedule Two to the Order:-

Milton Grove, Wigan	West	its junction with Tennyson Drive	a point 9 metres west of its junction with Tennyson Drive	on any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00am until 5.00pm
Milton Grove, Wigan	West	its junction with Wigan Lane	a point 7 metres south of its junction with Wigan Lane	on any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00am until 5.00pm
Milton Grove, Wigan	West	its junction with Wordsworth Avenue	a point 23 metres west of its junction with Wordsworth Avenue	on any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00am until 5.00pm

- (c) In relation to Schedule Seven, the following entries shall be added to Schedule Seven to the Order:-

Milton Grove, Wigan	West	a point 9 metres north of its junction with Tennyson Drive	a point 10 metres south of its junction with Wigan Lane	on any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00am until 5.00pm

Milton Grove, Wigan	East	a point 10 metres south of its junction with Tennyson Drive	a point 23 metres north of its junction with Wordsworth Avenue	on any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00am until 5.00pm

- (d) In relation to Schedule Two, the following entries shall be added to Schedule Two to the Order:-

Milton Grove, Wigan	West	its junction with Tennyson Drive	a point 9 metres north of its junction with Tennyson Drive	on any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00am until 5.00pm

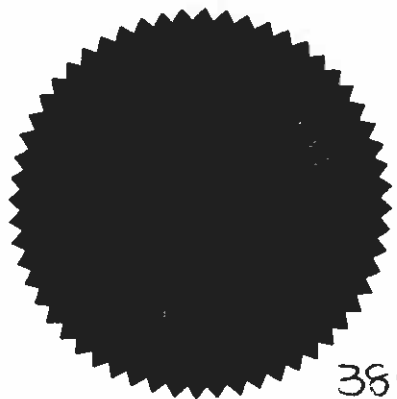
