**WIGAN BOROUGH(DECriminalISATION OF PARKING)  
(LEIGH ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004  
(AMENDMENT NO.36) ORDER 2009**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.36) Order 2009 and shall come into operation on 12 October 2009.
2. Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
  - (a) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Firs Lane, Leigh	North	A point 10 metres west of its junction with Faith Street	A point 10 metres east of its junction with Faith Street
Faith Street, Leigh	West	Its junction with Firs Lane	For a distance of 10 metres in a northerly direction
Faith Street, Leigh	East	Its junction with Firs Lane	For a distance of 6 metres in a northerly direction

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.

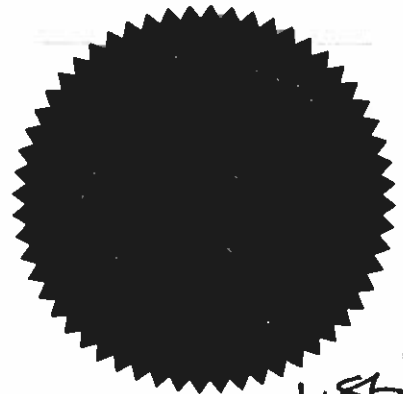
