**WIGAN BOROUGH(DECriminalISATION OF PARKING)
(LEIGH ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004
(AMENDMENT NO.38) ORDER 2009**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following

Order: -

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.38) Order 2009 and shall come into operation on 23rd November 2009.

2. Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-

- (a) In relation to Schedule One, the following entry shall be deleted from Schedule One to the Order:-

- (c) In relation to Schedule One, the following entry shall be added to Schedule One to the Order:-

Vernon Street, Leigh	East	Its junction with Bradshawgate	Its junction with Lord Street

- (d) In relation to Schedule Four, the following entries shall be added to Schedule Four to the Order:-

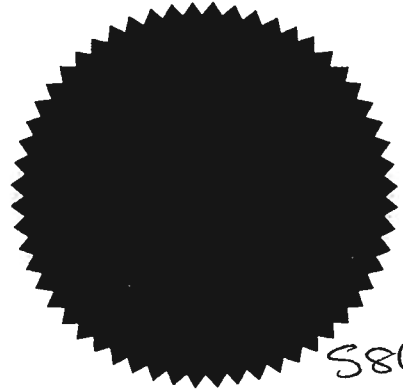
