**WIGAN BOROUGH(DECriminalISATION OF PARKING)  
(WIGAN ROADS NO. 2) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004  
(AMENDMENT NO. 32) ORDER 2010**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2) (Traffic Regulation Consolidation) Order 2004 (Amendment No.32) Order 2010 and shall come into operation on 13 April 2010.
2. Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
  - (a) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Kershaw Street Pemberton	South	A point 94.5 metres west of Loch Street	Its cul de sac end


- (b) In relation to Schedule Three, the following entries shall be added to Schedule Three to the Order

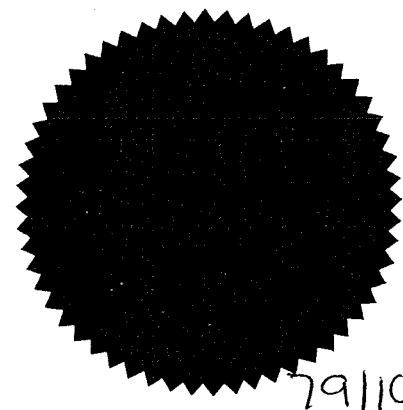

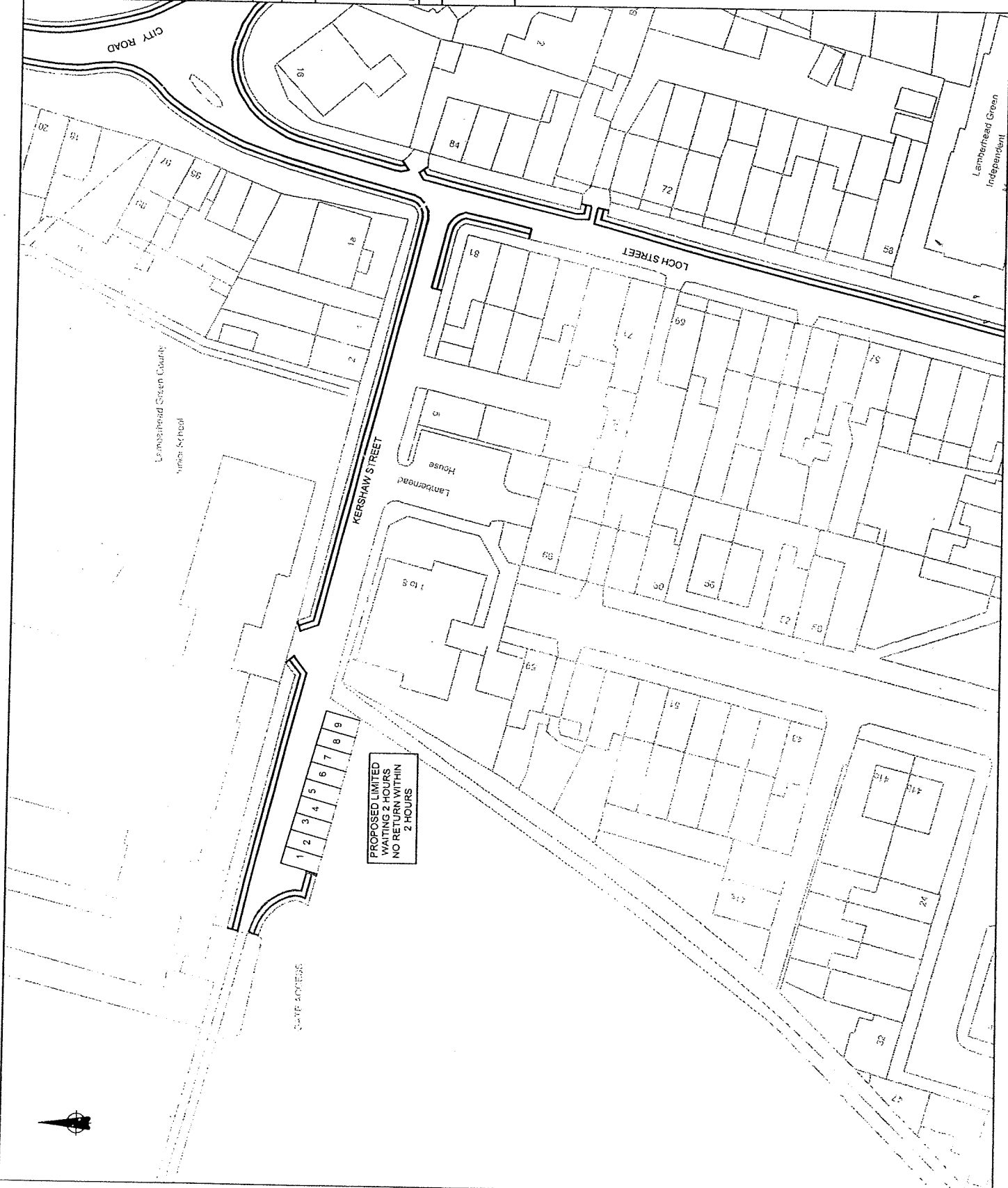
