WIGAN BOROUGH(DECRIMINALISATION OF PARKING) (VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO.56) ORDER 2010

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

- 1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No.56) Order 2010 and shall come into operation on 5 July 2010.
- 2. Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-

Schedule 1 Prohibition of Waiting

(a) In relation to Schedule One, the following entry/entries shall be deleted from Schedule One to the Order:-

Schedule 2 Restriction of Waiting

(b) In relation to Schedule Two, the following entry/entries shall be deleted from Schedule Two to the Order:-

Prescott Street, South East Hindley	A point 6 metres south west of its junction with Lord Street	For a distance of 30 metres in a south westerly direction	On any Monday, Tuesday, Wednesday, Thursday and Friday 7.30am - 6.30pm

(c) In relation to Schedule Four, the following entry/entries shall be deleted from Schedule Four to the Order:-

Thursday or Friday 7.30am – 9.30am and 4.00pm – 6.30pm

Schedule 1 Prohibition of Waiting

(a) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Prescott Street, Hindley	South East	It junction with Atherton Road	A distance of 14 metres in a south westerly direction
Prescott Street, Hindley	North West	Its junction with Atherton Road	A distance of 11 metres in a south westerly direction

Schedule 4 Prohibition/Restriction of Loading/Unloading

(b) In relation to Schedule Four, the following entries shall be added to Schedule Four to the Order:-

Prescott Street, Hindley	South East	It junction with Atherton Road	A distance of 14 metres in a south westerly direction	On any Monday, Tuesday, Wednesday, Thursday or Friday 7.30am - 9.30am and 4.00pm – 6.30pm
Prescott Street, Hindley	North West	Its junction with Atherton Road	A distance of 11 metres in a south westerly direction	On any Monday, Tuesday, Wednesday, Thursday or Friday 7.30am - 9.30am and 4.00pm – 6.30pm

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
