**(VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION)**  
**ORDER 2004**  
**(AMENDMENT NO.191)ORDER 2010**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No.191) Order 2010 and shall come into operation on 14 June 2010.
2. Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-

**Schedule 1 Prohibition of Waiting at any time**

- (a) In relation to Schedule One, the following entries shall be deleted from Schedule One to the Order:-

Warrington Road, Ashton	Both	its junction with Liverpool Road	a distance of 58 metres in a southerly direction
Warrington Road, Ashton	East	a point 15 metres north of its junction with Monica Terrace	a point 100 metres south of its junction with Flora Street
Warrington Road, Ashton	East	a point 15 metres north of its junction with Newlyn Drive	a point 15 metres south of its junction with Newlyn Drive

- (b) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Warrington Road, Ashton	Both	its junction with Liverpool Road	its junction with the Borough Boundary with St Helens
-------------------------	------	----------------------------------	-------------------------------------------------------

**Schedule 2 Restriction of Waiting**

- (a) In relation to Schedule Two, the following entries shall be deleted from Schedule Two to the Order:-

Warrington Road, Ashton	Both	a point 58 metres south of its junction with Liverpool Road	its junction with Vicarage Road	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 7.30am to 6.30pm

Schedule 9 Prohibition of Stopping at School Entrances

- (a) In relation to Schedule Nine, the following entries shall be deleted from Schedule Nine to the Order:-

Warrington Road, Ashton	West	a point 10 metres west of Park View	A point 17 metres south of Park View



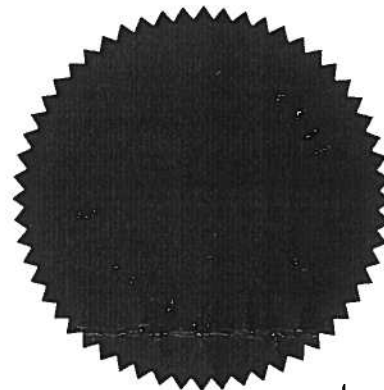
