THE WIGAN BOROUGH(DECRIMINALISATION OF PARKING) (VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO. 188) ORDER 2010

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

- This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 188) Order 2010 and shall come into operation on 10th May 2010.
- 2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-

Schedule 1 Prohibition of Waiting at Any Time

(a) In relation to Schedule One Prohibition of Waiting at Any Time, the following entries shall be deleted from Schedule One to the Order:-

Warrington Road, Abram	East	a point 35 metres north its junction with Lee Lane	a point opposite the northerly kerb line of Verda Street
Warrington Road, Abram	East	a point 15 metres north its junction with School Street	a point 16 metres south of its junction with Warrington Road

(b) In relation to Schedule One Prohibition of Waiting at Any Time, the following entries shall be added to Schedule One to the Order:-

Warrington Road, Abram	East	a point 10 metres north its junction with Willow Street	a point 10 metres south of its junction with Willow Street
Warrington Road, Abram	East	a point 10 metres north its junction with Dootson Street	a point 10 metres south of its junction with Dootson Street
Warrington Road, Abram	East	a point 15 metres north its junction with School Street	a point 16 metres south of its junction with School Street

Warrington Road, Abram	East	a point 35 metres north its junction with Lee Lane	a point 10 metres south of its junction with Mason Street
Warrington Road, Abram	East	a point 10 metres north its junction with Stephenson Street	a point 10 metres south of its junction with Stephenson Street
Warrington Road, Abram	East	a point 10 metres north its junction with Atkinson Street	a point 10 metres south of its junction with Atkinson Street
Warrington Road, Abram	East	a point 10 metres north its junction with Kirkham Street	a point 10 metres south of its junction with Kirkham Street

3. Save as provided in relation to the above amendments The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
