**WIGAN BOROUGH(DECriminalISATION OF PARKING)
(LEIGH ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004
(AMENDMENT NO.43) ORDER 2010**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.43) Order 2010 and shall come into operation on 31 December 2010.
2. Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entry shall be deleted from Schedule One to the Order:-

ROAD	SIDE	FROM	TO
Etherstone Street, Leigh	South	its junction with St Helens Road	its junction with Neild Gardens

- (b) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be added to Schedule One to the Order:-

ROAD	SIDE	FROM	TO
Etherstone Street, Leigh	South	its junction with St Helens Road	a point 5 metres west of its junction with Neild Gardens

ROAD	SIDE	FROM	TO
Etherstone Street, Leigh (Unnamed Passage East of No.21 Etherstone Street to Back Etherstone Street South leading to Neild Gardens)	Both	its junction with Etherstone Street	for a distance of 10 metres in a southerly direction

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
