**WIGAN BOROUGH(DECriminalISATION OF PARKING)
(WIGAN ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004
(AMENDMENT NO. 57) ORDER 2011**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 57) Order 2011 and shall come into operation on 15th August 2011.
2. The Wigan Borough (Decriminalisation of Parking) (Wigan Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-

Schedule 2 Restriction of Waiting

- (a) In relation to Schedule Two, Restriction of Waiting, the following entries shall be deleted from Schedule Two to the Order:-

ROAD	SIDE	FROM	TO	PERIOD OF OPERATION
Lime Street, Wigan	South and east	Its junction with Morris Street	Its junction with Butler Street	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00am-6.00pm
Scholes, Wigan	Northwest	Its junction with School Lane	Its junction with Greenough Street	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.30am-6.30pm
Scholes, Wigan	Southeast	Its junction with School Lane	Its junction with Greenough Street	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.30am-6.30pm

- (b) In relation to Schedule Two, Restriction of Waiting, the following entry shall be added to Schedule Two to the Order:-

ROAD	SIDE	FROM	TO	PERIOD OF OPERATION
Lime Street, Wigan	South and east	A point 10 metres south of its junction with Morris Street	Its junction with Butler Street	On any day between the hours 8.00am to 6.00pm

Schedule 1 Prohibition of Waiting at Any Time

- (c) In relation to Schedule One, Prohibition of Waiting at Any Time, the following entries shall be added to Schedule One to the Order:-

ROAD	SIDE	FROM	TO
Scholes, Wigan	Both	Its junction with Greenough Street and Scholefield Lane	Its junction with School Lane and Warrington Lane
Morris Street, Wigan	South	A point 10 metres north of its junction with Lime Street	A point 10 metres south of its junction with Lime Street
Lime Street, Wigan	Both	Its junction with Morris Street	A point 10 metres south of its junction with Morris Street
Morris Street, Wigan	Both	Its junction with Scholes	A point 15 metres north of its junction with Scholes
Vauxhall Road, Wigan	Both	Its junction with Scholes	A point 15 metres east of its junction with Scholes
Wellington Street, Wigan	Both	Its junction with Scholes	A point 15 metres east of its junction with Scholes
Morris Street, Wigan	North	A point 10 metres west of its junction with Windmill Close	A point 10 metres east of its junction with Windmill Close
Windmill Close, Wigan	Both	Its junction with Morris Street	For a distance of 10 metres in a northerly direction
Morris Street, Wigan	South	A point 10 metres west of its junction with Kay Close	A point 10 metres east of its junction with Kay Close

3. Save as provided in relation to the above amendments The Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
