**(AMENDMENT NO. 211) ORDER 2011**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 211) Order 2011 and shall come into operation on 19<sup>th</sup> December 2011.
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-

**Schedule One Prohibition of Waiting at any time**

- (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entry shall be added to Schedule One to the Order:-

<b>ROAD</b>	<b>SIDE</b>	<b>FROM</b>	<b>TO</b>
Holt Street, Orrell	Both	Its junction with St James Road	A point 10 metres north west of St James Road

**Schedule Two Restriction of Waiting**

- (a) In relation to Schedule Two, Restriction of Waiting, the following entry shall be deleted from Schedule Two to the Order:-

<b>ROAD</b>	<b>SIDE</b>	<b>FROM</b>	<b>TO</b>	<b>PERIOD OF OPERATION</b>
Holt Street, Orrell	North East	Its junction with St James Road	A point 7 metres north west of St James Road	On any Monday, Tuesday, Wednesday, Thursday or Friday 8.00am – 6.00pm

**Schedule Three Limited Waiting**

- (a) In relation to Schedule Three, Limited Waiting, the following entry shall be deleted from Schedule Three to the Order:-

ROAD	SIDE	FROM	TO	WAITING LIMITED TO (MINS)	RETURN PROHIBITED WITHIN (MINS)	PERIOD OF OPERATION
St James Road, Orrell	South East	A point 27 metres south west of Church Street	A point 45 metres south west of St James Road	30	60	At any time

(b) In relation to Schedule Three, Limited Waiting, the following entry shall be added to Schedule Three to the Order:-

ROAD	SIDE	FROM	TO	WAITING LIMITED TO (MINS)	RETURN PROHIBITED WITHIN (MINS)	PERIOD OF OPERATION
St James Road, Orrell	South East	A point 27 metres south west of Church Street	A point 45 metres south west of St James Road	30	60	On any day 7.00am – 7.00pm

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
