## THE WIGAN BOROUGH(DECRIMINALISATION OF PARKING) (WIGAN ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO.68) ORDER 2011

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

- This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.68) Order 2011 and shall come into operation on Monday 5<sup>th</sup> December 2011
- Wigan Borough (Decriminalisation of Parking) (Wigan Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
  - (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be deleted from Schedule One to the Order:-

Leyland Mill Lane, Wigan	West	Its junction with Wigan Lane, Wigan	A point 173 metres in a north easterly direction
Leyland Mill Lane, Wigan	East	Its junction with Wigan Lane, Wigan	A point 222 metres in a north easterly direction

(b) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be added to Schedule One to the Order:-

Leyland Mill Lane, Wigan	Both	Its junction with Wigan Lane, Wigan	Its junction with Hall Lane and Wingates Road
Wingates Road, Wigan	East	Its junction with Leyland Mill Lane and Hall Lane, Wigan	A point 15 metres north west of it junction with Leyland Mill Lane and Hall Lane
Wingates Road, Wigan	West	Its junction with Leyland Mill Lane and Hall Lane, Wigan	A point 24 metres north west of it junction with Leyland Mill Lane and Hall Lane
Hall Lane, Wigan	Both	Its junction with Leyland Mill Lane and Wingates Road, Wigan	For a distance of 110 metres in a north westerly, northerly and north easterly direction
