ORDER 2004
(AMENDMENT NO.214) ORDER 2011

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No.214) Order 2011 and shall come into operation on 10th October 2011.
2. Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be added to Schedule One to the Order:-

Road Name	Side	From	To
Downall Green Road, Bryn	North	A point 15 metres west of Soughers Lane, Bryn	Its junction with Soughers Lane, Bryn
Soughers Lane, Bryn	West	Its junction with Downall Green Road, Bryn	A point 20 metres north of Downall Green Road, Bryn
Soughers Lane, Bryn	East	A point 20 metres north of Downall Green Road, Bryn	A point 10 metres north of Downall Green Road, Bryn

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
