WIGAN BOROUGH(DECRIMINALISATION OF PARKING) (LEIGH ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO.56) ORDER 2011

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

- This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.56) Order 2011 and shall come into operation on 30th November 2011
- 2. Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be deleted from Schedule One to the Order:-

ROAD	SIDE	FROM	TO
Rydal Street, Leigh	Both	its junction with Twist Lane	for a distance of 15 metres in a northerly direction
Rydal Street, Leigh	West	A point 15 metres south of Railway Road	A point 15 metres north of Twist Lane
Rydal Street, Leigh	Both	Its junction with Railway Road	For a distance of 15 metres in a southerly direction

(b) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be added to Schedule One to the Order:-

ROAD	SIDE	FROM	TO
Rydal Street, Leigh	West	its junction with Twist Lane	Its junction with Railway Road
Rydal Street, Leigh	East	its junction with Twist Lane	for a distance of 5 metres in a northerly direction
Rydal Street, Leigh	East	Its junction with Railway Road	For a distance of 15 metres in a southerly direction

In relation to Schedule Three, Limited Waiting Monday to Saturday 9am to 5pm (c) 1 hour no return within 1 hour
