## (DECRIMINALISATION OF PARKING) (VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO.213) ORDER 2011

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

- 1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No.213) Order 2011 and shall come into operation on 13<sup>th</sup> August 2012.
- 2. Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
  - (a) In relation to Schedule Two, Restriction of Waiting, the following entries shall be deleted from Schedule Two to the Order:-

(b) In relation to Schedule One, No Waiting at any time, the following entries shall be added to Schedule One to the Order:-

Wigan Road, Standish	North East	Its junction with Grove Lane	A point 21 metres south of its junction with Grove Lane
Grove Lane, Standish	Both	Its junction with Wigan Road	A point 10 metres east of its junction with Heaton Street
Heaton Street, Standish	Both	Its junction with Grove Lane	A point 10 metres north of its junction with Grove Lane

(c) In relation to Schedule Two, Restriction of Waiting, the following entries shall be added to Schedule Two to the Order:-

Wigan Road, Standish	West	Its junction with High Street	A point 188 metres south of its junction with Grove Lane	On any day 8.00 am – 7.00 pm

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
