**WIGAN BOROUGH(DECriminalISATION OF PARKING)
(LEIGH ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004
(AMENDMENT NO.68) ORDER 2012**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.68) Order 2012 and shall come into operation on Friday 23rd November 2012.
2. Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entry shall be deleted from The Wigan Borough (Decriminalisation of Parking)(Leigh Roads)(Traffic Regulation Consolidation) Order 2004 – Amendment 40 to the Order:-

ROAD	SIDE	FROM	TO
Wigan Road, Leigh	East	A point 13 metres north of its junction with Stanhope Street	A point 6 metres south of its junction with Stanhope Street

- (b) In relation to Schedule Two, Restriction of Waiting, the following entry shall be deleted from The Wigan Borough (Decriminalisation of Parking)(Leigh Roads)(Traffic Regulation Consolidation) Order 2004 – Amendment 40 to the Order:-

ROAD	SIDE	FROM	TO	PERIOD OF OPERATION
Wigan Road, Leigh	East	A point 71 metres south of its junction with Browning Street	A point 13 metres north of its junction with Stanhope Street	Monday to Friday 7.30 am – 9.30 am and 4.00pm – 6.30pm

- (c) In relation to Schedule One, Prohibition of Waiting at any time, the following entry shall be added to Schedule One to the Order:-

ROAD	SIDE	FROM	TO
Wigan Road, Leigh	East	A point 29 metres north of its junction with Hulme Road	A point 6 metres south of its junction with Stanhope Street

- (d) In relation to Schedule Two, Restriction of Waiting, the following entry shall be added to Schedule Two of the Order:-

ROAD	SIDE	FROM	TO	PERIOD OF OPERATION
Wigan Road, Leigh	East	A point 71 metres south of its junction with Browning Street	A point 29 metres north of its junction with Hulme Road	Monday to Friday 7.30am – 9.30am and 4.00pm – 6.30pm

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
