WIGAN BOROUGH(DECRIMINALISATION OF PARKING) (WIGAN ROADS NO. 2) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO.44) ORDER 2013

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

- This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2) (Traffic Regulation Consolidation) Order 2004 (Amendment No.44) Order 2013 and shall come into operation on 16th April 2013.
- 2. Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be deleted from Schedule One to the Order:-

Leader Street, Pemberton	Both	Its junction with Ormskirk Road	Its junction with Major Street
Major Street, Pemberton	South West	Its junction with Leader Street	A point opposite the south-easterly kerb line of Orpington Street

(b) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be added to Schedule One to the Order:-

ROAD	SIDE	FROM	ТО
Leader Street, Pemberton	Both	Its cul-de-sac end (Major Street)	For a distance of 10 metres in a northerly direction
Major Street, Pemberton	West	Its junction with Ormskirk Road	For a distance of 70 metres in a northerly direction
Major Street, Pemberton	East	Its junction with Ormskirk Road	For a distance of 40 metres in a northerly direction

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
