**WIGAN BOROUGH (OFF STREET PARKING PLACES) (RAILWAY ARCHES  
CAR PARK, LEIGH) ORDER 2012 (AMENDMENT) ORDER 2013**

The Wigan Borough Council in exercise of its powers under Section 35 of the Road Traffic Act 1984 and under the Traffic Management Act 2004 and of all other enabling powers, hereby makes the following Order:-

1. This Order may be cited as the Wigan Borough (Off Street Parking Places) (Railway Arches Car Park, Leigh) Order 2012 (Amendment) Order 2013 and shall come into operation on 11<sup>th</sup> February 2013.
2. Any reference in this Order to a numbered Article is a reference to the Article having that number in the Order.
3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
4. The Wigan Borough (Off Street Parking Places) (Railway Arches Car Park, Leigh) Order 2012 shall be amended by:
  - (i) Deleting Article 3(1) of the Order and inserting:-

"3 (1) The parking place may be used on any day Monday to Saturday (other than a Bank or Public Holiday) between 8.00 am and 6.00pm on payment of the relevant charge as the charges to be paid in connection with the use of the parking place subject to the provisions of this Order, as a place in which vehicles of the specified class may wait."
  - (ii) Deleting Article 6(1) of the Order and inserting:

"6 (1) A vehicle shall not be left in the parking place on any day (other than a Bank or Public Holiday) between 8.00 am and 6.00 pm for longer than the relevant period for which payment was made, or for longer than that period and any further period for which payment has been made in accordance with Article 5(4)".
