WIGAN BOROUGH(DECRIMINALISATION OF PARKING) (LEIGH ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO. 81) EXPERIMENTAL ORDER 2013

Wigan Borough Council, in exercise of its powers under Section 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order -

- This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 81) Experimental Order 2013 and shall come into operation on 14th October 2013 for an experimental period of 18 months.
- 2. Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
