## WIGAN BOROUGH(DECRIMINALISATION OF PARKING) (WIGAN ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO.90) ORDER 2013

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

- 1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.90) Order 2013 and shall come into operation on 13<sup>th</sup> May 2014.
- Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
  - (a) In relation to Schedule Two, Restriction of Waiting, the following entries shall be deleted from Schedule Two to the Order:-

(b) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be added to Schedule One to the Order:-

Turner Street, Wigan	West	A point 9 metres north of its junction with Greenough Street	A point 16 metres north of its junction with Greenough Street
Turner Street, Wigan	East	A point 9 metres north of its junction with Greenough Street	A point 58 metres north and north east of its junction with Greenough Street

(c) In relation to Schedule Two, Restriction of Waiting, the following entry shall be added to Schedule Two of the Order:-

Turner Street, Wigan	West	A point 16 metres north of its junction with Greenough Street	Its northern end	On any Monday, Tuesday, Wednesday, Thursday or Friday 8.30am – 5.00pm

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Wigan Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
