

**WIGAN BOROUGH(DECriminalISATION OF PARKING)**  
**(LEIGH ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004**  
**(AMENDMENT NO. 88) (EXPERIMENTAL) ORDER 2014**

Wigan Borough Council, in exercise of its powers under Section 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order -

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 88) (Experimental) Order 2014 and shall come into operation on 14<sup>th</sup> May 2014 for an experimental period of 11 months.
2. Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
  - (a) In relation to Schedule One, Prohibition of Waiting, the following entry shall be added to Schedule One to the Order:-

Hanover Street, Leigh	East	A point 19 metres north of its junction with Brookfield Street	A point 9 metres south of its junction with Brookfield Street
Brookfield Street, Leigh	North West	Its junction with Hanover Street	A point 12 metres north east of its junction with Hanover Street
Brookfield Street, Leigh	South East	Its junction with Hanover Street	A point 14.5 metres east of its junction with Hanover Street
Hanover Street, Leigh	Both	Its junction with Holden Road	A point 10 metres north of its junction with Holden Road
Holden Road, Leigh	North	A point 11 metres east of its junction with Hanover Street	A point 10 metres west of its junction with Hanover Street
Charles Street, Leigh	East	A point 29 metres south of its junction with The Avenue	A point 36.5 metres south of its junction with The Avenue
Charles Street, Leigh	East	A point 25 metres north of its junction with Holden Road	A point 34 metres north of its junction with Holden Road
Charles Street, Leigh	East	Its junction with Arundel Drive	A point 50 metres south of its junction with Arundel Drive
Arundel Drive, Leigh	North	Its junction with Charles Street	A point 10 metres west of its junction with Charles Street
Charles Street, Leigh	West	Its junction with Arundel Drive	A point 10 metres north of its junction with Arundel Drive
Charles Street, Leigh	East	Its junction with Arundel Drive	A point 14.5 metres north of its junction with Arundel Drive



- (b) In relation to Schedule One, Prohibition of Waiting, the following entry shall be deleted from Schedule One to the Order:-

Road	Side	From	To
Hanover Street, Leigh (Amendment 24)	East	A point 10 metres south of its junction with Brookfield Street	A point 10 metres north of its junction with Brookfield Street
Brookfield Street, Leigh (Amendment 24)	Both	Its junction with Hanover Street	For a distance of 10 metres in a north easterly direction

- (c) In relation to Schedule Two, Restriction of Waiting, the following entry shall be added to Schedule Two to the Order:-

Hanover Street, Leigh	East	A point 15 metres south of its junction with The Avenue	A point 19 metres north of its junction with Brookfield Street	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00am – 5.00pm
Hanover Street, Leigh	East	A point 9 metres south of its junction with Brookfield Street	A point 10 metres north of its junction with Holden Road	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00am – 5.00pm
Charles Street, Leigh	West	A point 10 metres north of its junction with Holden Road	A point 10 metres south of its junction with The Avenue	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00am – 5.00pm
