WIGAN BOROUGH(DECriminalISATION OF PARKING)
(VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION)
ORDER 2004
(AMENDMENT NO. 283) ORDER 2013

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 283) Order 2013 and shall come into operation on 10th March 2014.
2. Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, Restriction of Waiting, the following entries shall be added to Schedule One to the Order:-

Road	Side	From	To	Period of Operation
Simpkin Street, Abram	South	A point 30 metres west of Ruskin Crescent	A point 15 metres east of Ruskin Crescent	On any Monday, Tuesday, Wednesday, Thursday or Friday 8.00 am – 5.00 pm
Ruskin Crescent, Abram	Both	Its junction with Simpkin Street	A point 15 metres south of Simpkin Street	On any Monday, Tuesday, Wednesday, Thursday or Friday 8.00 am – 5.00 pm

- (b) In relation to Schedule Nine, Prohibition of Stopping at School Entrances, the following entry shall be deleted from Schedule Nine to the Order:-

Road	Side	From	To
Simpkin Street, Abram	South	A point 85 metres east of Vicarage Road	For a distance of 53 metres in an easterly direction

- (c) In relation to Schedule Nine, Prohibition of Stopping at School Entrances, the following entries shall be added to Schedule Nine to the Order:-

Road	Side	From	To
Simpkin Street, Abram	South	A point 30 metres west of Ruskin Crescent	For a distance of 25.56 metres in a westerly direction
Simpkin Street, Abram	South	A point 57.56 metres west of Ruskin Crescent	For a distance of 25.56 metres in a westerly direction


3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
