**WIGAN BOROUGH(DECriminalISATION OF PARKING)
(LEIGH ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004
(AMENDMENT NO.89) ORDER 2014**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.89) Order 2014 and shall come into operation on 30th June 2014.
2. Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be deleted from Schedule One to the Order:-

Unnamed lane leading to Cawdor Street, Leigh	Both	Its junction with the unnamed road leading to Ellesmere Street	Its junction with Cawdor Street
Unnamed road leading to Ellesmere Street, Leigh	West	Its junction with Spinning Jenny Way	Its junction with Ellesmere Street
Cawdor Street, Leigh (amendment 62 – 06.04.12)	South	A point 8 metres east of its junction with Ellesmere Street	Its westerly cul-de-sac

- (b) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be added to Schedule One to the Order:-

ROAD	SIDE	FROM	TO
Cawdor Street, Leigh	East and South	Its junction with Ellesmere Street	For a distance of 29 metres in a north then easterly direction
Cawdor Street, Leigh	West and South	Its junction with Ellesmere Street	For a distance of 36 metres in a north then westerly direction
Ellesmere Street, Leigh	West and North	A point 20 metres south of its junction with Spinning Jenny Way	For a distance of 147 metres in a south then westerly direction

- (b) In relation to Schedule Two, Restriction of Waiting, the following entries shall be deleted to Schedule Two of the Order:-

Unnamed road leading to Ellesmere Street, Leigh	East	Its junction with Spinning Jenny Way	Its junction with Ellesmere Street	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday

Ellesmere Street, Leigh	Both	Its junction with the unnamed road leading to Ellesmere Street	Its end	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00am – 6.00pm
Cawdor Street, Leigh (Amendment 62 – 06.04.12)	South	A point 13 metres east of its junction with Ellesmere Street	Its easterly cul-de-sac	On any Monday, Tuesday, Wednesday, Thursday or Friday 8.00am to 6.00pm

(c) In relation to Schedule Two, Restriction of Waiting, the following entries shall be added to Schedule Two of the Order:-

ROAD	SIDE	FROM	TO	PERIOD OF OPERATION
Cawdor Street, Leigh	South	A point 29 metres north then east of its junction with Ellesmere Street	Its easterly cul-de-sac end	On any Monday, Tuesday, Wednesday, Thursday or Friday 8.00am – 6.00pm
Ellesmere Street, Leigh	West	A point 147 metres south then west of its junction with Spinning Jenny Way	Its cul-de-sac end	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00am to 6.00pm
Ellesmere Street, Leigh	East and South	A point 20 metres south of its junction with Spinning Jenny Way	Its cul-de-sac end	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00am to 6.00pm

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
