WIGAN BOROUGH(DECRIMINALISATION OF PARKING) (LEIGH ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO.89) ORDER 2014

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

- 1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.89) Order 2014 and shall come into operation on 30th June 2014.
- 2. Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
