THE WIGAN BOROUGH(DECRIMINALISATION OF PARKING) (LEIGH ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO. 87) ORDER 2014

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

- This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 87) Order 2014 and shall come into operation on 31st October 2014.
- 2. The Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, Prohibition of Waiting, the following entries shall be added to Schedule One to the Order:-

(b) In relation to Schedule Fifteen Privileged Parking Places and Limited Waiting, the following entry shall be added to Schedule Fifteen to the Order:-
