**WIGAN BOROUGH(DECriminalISATION OF PARKING)
(LEIGH ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004
(AMENDMENT NO.100) ORDER 2015**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order -

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.100) Order 2015 and shall come into operation on 26th June 2015.
2. Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entry shall be introduced to Schedule One to the Order:-

Road	Side	From	To
Vernon Street, Leigh	West	Its junction with Bradshawgate	A point 8 metres north of its junction with Bradshawgate

- (b) In relation to Schedule Three, Limited Waiting, the following entries shall be deleted from Schedule Three to the Order:-

Road	Side	From	To	Waiting Limited To (mins)	Return Prohibited Within (mins)	Period of Operation
Lord Street, Leigh	South	A point 2 metres east of its junction with Vernon Street	A point 3 metres west of its junction with Charles Street	30	60	On any day
Lord Street, Leigh	South	Its junction with Charles Street	Its junction with Bedford Street	30	60	On any day
Lord Street, Leigh	South	A point 11 metres east of its junction with Union Street	A point 8 metres west of its junction with Silk Street	30	60	On any day
Vernon Street, Leigh	West	A point 32 metres north of its junction with Bradshawgate	For a distance of 26 metres in a northerly direction	30	60	On any day 8.00am – 6.00pm

- (c) In relation to Schedule Three, Limited Waiting, the following entries shall be added to Schedule Three to the Order:

Road	Side	From	To	Waiting Limited To (mins)	Return Prohibited Within (mins)	Period of Operation
Lord Street, Leigh	South	A point 11 metres east of its junction with Union Street	A point 8 metres west of its junction with Silk Street	30	60	On any day 8am – 6pm
Vernon Street, Leigh	West	A point 16 metres south of its junction with Lord Street	A point 27 metres south of its junction with Lord Street	30	60	On any day 8am – 6pm

- (d) In relation to Schedule Four, Restriction of Loading, the following entry shall be deleted from Schedule Four to the Order:-

Road	Side	From	To	Period of Operation
Vernon Street, Leigh (Amendment No. 38)	West	Its junction with Bradshawgate	For a distance of 32 metres in a northerly direction	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00am to 6.00pm

- (e) In relation to Schedule Four, Prohibition of Loading, the following entry shall be introduced to Schedule Four to the Order:-

Road	Side	From	To	Period of Operation
Vernon Street, Leigh	West	Its junction with Bradshawgate	A point 8 metres north of its junction with Bradshawgate	At any time

- (f) In relation to Schedule Fourteen, Loading Bays, the following entry shall be introduced to Schedule Fourteen to the Order:-

Road	Side	From	To	Period of Operation
Vernon Street, Leigh	West	A point 8 metres north of its junction with Bradshawgate	A point 32 metres north of its junction with Bradshawgate	At any time

- (g) In relation to Schedule Fifteen, Privileged Parking Places and Limited Waiting, the following entries shall be introduced to Schedule Fifteen to the Order:-

Road	Side	From	To	Waiting Limited To (mins)	Return Prohibited Within (mins)	Period of Operation	Permitted Hours
Lord Street, Leigh	South	A point 2 metres east of its junction with Vernon Street	A point 3 metres west of its junction with Charles Street	60	60	On any Monday – Saturday 9am – 5pm	On any Monday – Saturday 9am – 5pm
Lord Street, Leigh	South	Its junction with Charles Street	Its junction with Bedford Street	60	60	On any Monday – Saturday 9am – 5pm	On any Monday – Saturday 9am – 5pm

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
