WIGAN BOROUGH(DECriminalISATION OF PARKING)
(LEIGH ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004
(AMENDMENT NO.106) ORDER 2015

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.106) Order 2015 and shall come into operation on 13th November 2015.
2. Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-

- (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be added to Schedule One to the Order:-

Road	Side	From	To
Eyet Street, Leigh	West	Its junction with Railway Road	A point 67 metres north of its junction with Railway Road
Buchanan Street, Leigh	South	A point 5 metres east of its junction with Dorning Street	A point 5 metres west of its junction with Dorning Street
Dorning Street, Leigh	East	Its junction with Buchanan Street	A point 10 metres south of its junction with Buchanan Street
Dorning Street, Leigh	West	Its junction with Buchanan Street	A point 5 metres south of its junction with Buchanan Street
Dorning Street, Leigh	Both	Its junction with Railway Road	A point 2 metres north of its junction with Railway Road
Ulleswater Street, Leigh	West	Its junction with Railway Road	A point 5 metres south of its junction with Railway Road
Organ Street, Leigh	Both	Its junction with Railway Road	A point 5 metres south of its junction with Railway Road
Rydal Street, Leigh	East	Its junction with Railway Road	A point 10 metres south of its junction with Railway Road

- (b) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be deleted from Schedule One to the Order:-

Road	Side	From	To
Eyet Street, Leigh	West	Its junction with Railway Road	For a distance of 7 metres in a northerly

			direction
Eyet Street, Leigh	West	A point 30 metres north of its junction with Railway Road	A point 67 metres north of its junction with Railway Road
Dorning Street, Leigh	East	Its junction with Railway Road	For a distance of 31 metres in a northerly direction
Dorning Street, Leigh	West	Its junction with Railway Road	For a distance of 15 metres in a northerly direction
Ulleswater Street, Leigh	West	Its junction with Railway Road	For a distance of 15 metres in a southerly direction
Organ Street, Leigh	Both	Its junction with Railway Road	For a distance of 15 metres in a southerly direction
Rydal Street, Leigh	East	Its junction with Railway Road	For a distance of 15 metres in a southerly direction

- (c) In relation to Schedule Two, Restriction of Waiting, the following entries shall be deleted from Schedule Two to the Order:-

Road	Side	From	To	Period of Operation
Dorning Street, Leigh	West	Its junction with Buchanan Road	A point 15 metres north of its junction with Railway Road	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00am - 6.00pm
Jaffrey Street, Leigh	West	A point 15 metres north of its junction with Railway Road	A point 29 metres north of its junction with Railway Road	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00am-6.00pm

- (d) In relation to Schedule Eight, Doctors Parking Places, the following entry shall be deleted from Schedule Eight to the Order:-

Road	Side	From	To	No. of Parking spaces	Period of Operation
Jaffrey Street, Leigh	West	A point 9 metres north of its junction with Railway Road	A point 15 metres north of its junction with Railway Road	2	At any time

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
