

**WIGAN BOROUGH COUNCIL**

**THE WIGAN BOROUGH(DECriminalISATION OF PARKING)  
(WIGAN ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004  
(AMENDMENT NO. 102) ORDER 2014**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 102) Order 2014 and shall come into operation on 21<sup>st</sup> April 2015.
2. The Wigan Borough (Decriminalisation of Parking) (Wigan Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-

- (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be added to Schedule One to the Order:-

ROAD	SIDE	FROM	TO
Frog Lane, Wigan	North east	Its junction with Woodhouse Lane	A point 10 metres east of vehicular access to Markland Court
Frog Lane, Wigan	South west	Its junction Woodhouse Lane	A point 79 metres west of its junction with Lower St Stephen Street

- (b) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be deleted from Schedule One to the Order:-

ROAD	SIDE	FROM	TO
Frog Lane, Wigan	North east	Where Frog Lane merges with Woodhouse Lane	A point 160 metres west of its junction with Lower St Stephen Street
Frog Lane, Wigan	West	Its junction Woodhouse Lane	A point 260 metres west of its junction with Lower St Stephen Street

- (c) In relation to Schedule Four, Prohibition/Restriction of Loading/Unloading, the following entries shall be added to Schedule Four to the Order:-

ROAD	SIDE	FROM	TO	PERIOD OF OPERATION
Frog Lane, Wigan	North east	Its junction with Woodhouse Lane	A point 10 metres east of the vehicular access to Markland Court	At any time
Frog Lane, Wigan	South west	Its junction Woodhouse Lane	A point 79 metres west of its junction with Lower St Stephen Street	At any time

- (d) In relation to Schedule Four, Prohibition/Restriction of Loading/Unloading, the following entries shall be deleted from Schedule Four to the Order:-

ROAD	SIDE	FROM	TO	PERIOD OF OPERATION
Frog Lane, Wigan	North east	Its junction with Woodhouse Lane	A point 160 metres west of its junction with Lower St Stephen Street	At any time
Frog Lane, Wigan	West	Its junction Woodhouse Lane	A point 260 metres west of its junction with Lower St Stephen Street	At any time

3. Save as provided in relation to the above amendments The Wigan Borough (Decriminalisation of Parking) (Wigan Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
