WIGAN BOROUGH(DECriminalISATION OF PARKING)
(Wigan Roads No. 2) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004
(AMENDMENT NO.74) ORDER 2016

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2) (Traffic Regulation Consolidation) Order 2004 (Amendment No.74) Order 2016 and shall come into operation on 6th October 2016.
2. Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - a) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be deleted from Schedule One to the Order:-

Road	Side	From	To
Billinge Road, Pemberton	Both	a point 15 metres west of its junction with Tunstall Lane	A point 15 metres east of its junction with Little Lane
Billinge Road, Pemberton	Both	a point 15 metres east of its junction with Little Lane	A point 15 metres east of its junction with Edinburgh Drive
Billinge Road, Pemberton	Both	a point 15 metres west of its junction with Warncliffe Street	A point 15 metres west of its junction with Tunstall Lane

- b) In relation to Schedule One, Prohibition of Waiting at any time the following entries shall be added to Schedule One to the Order:-

Road	Side	From	To
Billinge Road, Wigan	Both	A point 15 metres west of its junction with Warncliffe Street	A point 15 metres east of its junction with Edinburgh Drive
Holden Walk, Wigan	Both	Its junction with Billinge Road	A point 10 metres south-easterly of its junction with Billinge Road

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
