**THE WIGAN BOROUGH(DECriminalISATION OF PARKING)
(VARIOUS ROADS IN THE WIGAN BOROUGH) (TRAFFIC REGULATION
CONSOLIDATION) ORDER 2004
(AMENDMENT NO. 369) ORDER 2016**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Various Roads in the Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 369) Order 2016 and shall come into operation on 9th August 2016.
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in the Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be added to Schedule One to the Order:-

Benjamin Fold, Bryn	North	Its junction with Nicol Mere Drive	A point 10 metres south west of its junction with Nicol Mere Drive
Benjamin Fold, Bryn	South	Its junction with Nicol Mere Drive	A point 52 metres south east then in a south-westerly direction from its junction with Nicol Mere Drive
Benjamin Fold, Bryn	South	A point 64 metres south east of its junction with Nicol Mere Drive	A point 54 metres north west and then in a south westerly direction
Highwoods Close, Bryn	North	A point 121 metres south east then in a north-easterly direction of its junction with Nicol Mere Drive	A point 20 metres north east and then in a north westerly direction
Highwoods Close, Bryn	North	A point 150 metres south east and then in a north- easterly direction of its junction with Nicol Mere Drive	A point 25 metres south west and then in a north- westerly direction
Highwoods Close, Bryn	South	A point 125 metres south east and then in a north-	A point 161 metres north east of its junction with Nicol

- (b) In relation to Schedule Two, Restriction of Waiting, the following entries shall be deleted from Schedule Two to the Order:-

ROAD	SIDE	FROM	TO	PERIOD OF OPERATION
Benjamin Fold, Bryn	Both	Its junction with Nicol Mere Drive	A point 10 metres south west of its junction with Nicol Mere Drive	On any Monday, Tuesday, Wednesday, Thursday or Friday 10.00am – 4.00pm

3. Save as provided in relation to the above amendments The Wigan Borough (Decriminalisation of Parking) (Various Roads in the Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
