THE WIGAN BOROUGH(DECRIMINALISATION OF PARKING) (VARIOUS ROADS IN THE WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO. 369) ORDER 2016

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

- 1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Various Roads in the Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 369) Order 2016 and shall come into operation on 9th August 2016.
- 2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in the Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be added to Schedule One to the Order:-
