WIGAN BOROUGH (OFF STREET PARKING PLACES) (PENALTY CHARGE FOR OFFENCES) ORDER 1994

The Wigan Borough Council, in exercise of its powers under Section 35 of the Road Traffic Regulation Act 1984, hereby makes the following Order -

- 1.(1) This Order may be cited as The Wigan Borough (Off Street Parking Places) (Penalty Charge for Offences) Order 1994 and shall come into operation on the 7th November 1994.
- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2. The Wigan Borough (Off Street Parking Places)(Chapel Lane, Harrogate Street and Rodney Street Car Parks, Wigan) Order 1994 shall be amended by the addition thereto of the following new Article
 - "18. If the driver of any vehicle fails to comply with any of the provisions of this Order he shall incur a penalty charge of twenty five pounds"
- 3. The Wigan Borough (Off Street Car Parks) (Civic Centre, 50 Millgate, Station Road East and West Sides and Mona Street East Side) (Wigan) (Charges) Order 1991 shall be amended by the addition thereto of the following new Article -
 - "11. If the driver of any vehicle fails to comply with any of the provisions of this Order he shall incur a penalty charge of twenty five pounds"
- 4. The Wigan Borough (Off Street Parking Places) (Mona Street West Side Car Park, Wigan) Order 1993 and the Wigan Borough (Off Street Parking Places) (Silk Street Car Park, Leigh) Order 1992 shall be amended by the addition therefore of the following new Article -
 - "19. If the driver of any vehicle fails to comply with any of the provisions of this Order he shall incur a penalty charge of twenty five pounds"
- The Wigan Borough (Off Street Parking Places) (Mona Street East Side Car Park, Wigan) Order 1992 and the Wigan Borough (Off Street Parking Places) (Church Street, District Office/Library and Lord Street Car Parks, Leigh) Order 1992 and the Wigan Borough (Off Street Parking Places) (Doctor's Nook Car Park, Leigh) Order 1991 and the Wigan Borough (Off Street Parking Places) (Spinning Gate Car Park, Leigh) Order 1989 shall be amended by the addition thereto of the following new Article -

"20. If the driver of any vehicle fails to comply with any of the provisions of this Order he shall incur a penalty charge of twenty five pounds"
