THE WIGAN BOROUGH (OFF STREET PARKING PLACES) (AMENDMENT) ORDER 1997

The Wigan Borough Council, in exercise of its powers under Section 35 of the Road Traffic Regulation Act 1984 hereby makes the following Order:-

- 1.(1) This Order may be cited under the Wigan Borough (Off Street Parking Places)(Amendment) Order 1997 and shall come into operation on the 17th March 1997.
- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2. In this Order "vehicle licence" has the same meaning as in the Vehicle Excise and Registration Act 1994.

4. The Wigan Borough (Off Street Parking Places) (The Galleries Car Park, Wigan) Order 1991 shall be amended as follows:-
