ROAD TRAFFIC REGULATION ACT 1984

THE COUNTY OF WILTSHIRE (VARIOUS ROADS, LARKHILL IN THE PARISH OF DURRINGTON) (PROHIBITION OF WAITING) ORDER 1996

The Council of the County of Wiltshire ("the Council") in exercise of its powers under Sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1. Save as provided in Articles 2, 3 and 4 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a traffic warden, cause or permit any vehicle to wait in any of the lengths of road specified in the Schedule to this Order.
- 2. Nothing in Article 1 of this Order shall prevent any person from causing or permitting any vehicle to wait in any of the lengths of road referred to in that Article for so long as may be necessary:-
 - (a) to enable a person to board or alight from the vehicle;
 - (b) to enable goods to be loaded onto or unloaded from the vehicle;
 - (c) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road so referred to or the laying, erection, alteration or repair in or near to any of the said lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878;
 - (d) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers or duties;
 - (e) to enable the vehicle to take in petrol, oil, water or air from any garage situated in or adjacent to the said length of road; or
 - (f) to enable the vehicle to be loaded or unloaded while it is in actual use in connection with the removal of furniture from one office or dwellinghouse to another or the removal of furniture from such premises to a depository or to such premises from a depository notwithstanding anything contained in paragraph (b) above, provided notice is given 24 hours in advance to the Police, their consent is obtained and such reasonable conditions as they may impose are complied with.

- 3. Nothing in Article 1 of this Order shall apply to any vehicle:-
 - (a) being used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953; or
 - (b) owned by a funeral director of owner of funeral vehicles when used as part of funeral cortege or otherwise in connection with a funeral; or
 - (c) being licensed as a hackney carriage while waiting at a duly authorised cab rank as marked on the carriageway within the lengths of road referred to in the said Articles 1 and 2.
- 4. Nothing in Article 1 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait in any of the lengths of road referred to in those Articles for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same road or part of a road on the same day).

5. In this Order -

"disabled person's vehicle" means a vehicle lawfully displaying a disabled person's badge.

"disabled person's badge" means any badge issued, or having effect as if issued, under any regulations for the time being in force under Section 21 of the Chronically Sick and Disabled Persons Act 1970.

"parking disc" means a disc, issued by a local authority, complying with the requirements of the British Standard Specifications for Parking Discs (BS No. 4631: 1970), coloured orange, and capable of showing the quarter hour period during which a period of waiting begins; and

"relevant position" means:-

- 1. a vehicle displays a disabled person's badge issued before 2nd March, 1992, in the relevant position if
 - (a) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon on the nearside of and immediately behind the windscreen and with its front facing forward so as to be legible from outside the vehicle; or
 - (b) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or near side of the vehicle.

- 2. a vehicle displays a disabled person's badge issued on or after 2nd March 1992 in the relevant position if
 - (a) in the case of a vehicle fitted with a dashboard or facia panel, the badge is exhibited thereon so that Part 1 of the badge is legible from outside the vehicle; or
 - (b) in the case of a vehicle not fitted with a dashboard or facia panel the badge is exhibited in a conspicuous position on the vehicle so that Part 1 of the badge is legible from outside the vehicle.
- 6. This Order shall come into operation on the 25 March 1996 and may be cited as The County of Wiltshire (Various Roads, Larkhill in the Parish of Durrington)(Prohibition of Waiting) Order 1996.
