**ROAD TRAFFIC REGULATION ACT 1984**

**WILTSHIRE COUNTY COUNCIL (RESIDENTS' PARKING PLACES,  
SALISBURY) (VISITORS' PARKING PERMITS) ORDER 1996**

The Wiltshire County Council in exercise of their powers under Sections 45, 46, 49, 53, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. The following Orders are hereby amended:-

- (a) Wiltshire County Council (Salisbury) (St. Edmund's Area) (Residents' Parking Places) Order, 1989;
- (b) Wiltshire County Council (Salisbury) (East Street/West Street Area) (Residents' Parking Places) Order 1992;
- (c) Wiltshire County Council (Salisbury) (Milford Area) (Residents' Parking Places) Order 1992;
- (d) Wiltshire County Council (Salisbury) (St. Paul's Area) (Residents' Parking Places) Order 1992;
- (e) Wiltshire County Council (Manor Road, Salisbury) (Residents' Parking Places) Order 1995;

A. Article 6(2) of Orders (b)-(e) shall be deleted and amended to read as follows:  
in the case of Order (a) the following shall be inserted as Article 6 (1)B:

**"6(2) Visitor's Permit**

- (i) Any domestic resident whose usual residence is at a premises, the postal address of which is in any street or part of a street described in Schedule 2 to this Order, may apply for a Visitors Permit for use on any passenger vehicle, dual purpose vehicle, goods vehicle or motor cycle belonging to any visitor to the household, for the leaving of that vehicle in a designated parking place. Such application shall be made on a form issued by and obtainable from the Council and shall include the information required by such form.
- (ii) A maximum of two permits per household may be applied for at any time.
- (iii) A visitors permit shall be valid from the dates as requested on the application and as shown on the permit, up to a maximum of one month.



- (iv) Any domestic resident over sixty years of age living in a household to whom no permit has been issued, may apply to the Council for the issue of a visitor's permit for use on any passenger vehicle, dual purpose vehicle, goods vehicle or motor cycle belonging to any visitor to the household for the leaving in a designated parking place of that vehicle and such application shall be made on a form issued by and obtainable from the Council and shall include the information required by such form. Such permits shall be valid for a period of one year. Any domestic residents over sixty years of age may also apply for a short-term visitors permit in accordance with Article 6(2)(i)."

B. Article 6(4) of the Orders shall be amended to include:

"6(4)(c) a domestic resident who does not hold more than one valid visitors parking permit in accordance with Article 6(2)(a)(ii), shall issue to that applicant one permit (or in the case of a domestic resident holding no visitors permits a maximum of two) permit(s) for the leaving during the permitted hours in a parking space in any parking place, of the vehicle to which such permit relates."

C. Article 2 of the Orders shall be amended by deletion of the definition of "permit" and inserting in its place the following:-

"Permit" means a permit issued under the provisions of Article 6 of this Order."

D. Article 9(B) of the Orders shall be amended by the insertion of the following:

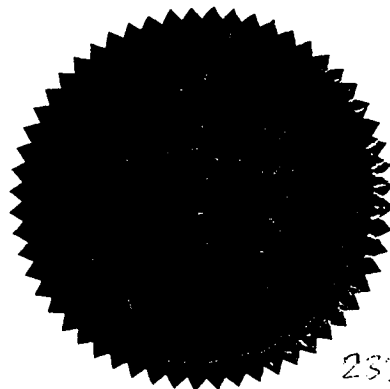
"(f) the vehicle registration number (except in the case of visitors permits issued to domestic residents over sixty years of age)."

2. This Order shall come into operation on the 14th day of October 1996 and may be cited as Wiltshire County Council (Residents Parking Places, Salisbury) (Visitors Parking Permits) Order 1996.
