ROAD TRAFFIC REGULATION ACT 1984

WILTSHIRE COUNTY COUNCIL (SALISBURY - ZONE B)
(WAITING RESTRICTIONS AND RESIDENTS PARKING BAY) ORDER 1997

The Council of the County of Wiltshire ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 45, 46, 49, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

Amendments and Revocations

1(1) The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting and Loading and Unloading) Traffic Regulation Order 1979 (hereinafter referred to as "the Order of 1979") shall be further amended by:-

- (a) The deletions from Schedule 1 of the Order of 1979 of the lengths of road specified in Schedule 1 to this Order.
- (b) The deletions from Schedule 2 of the Order of 1979 of the lengths of road specified in Schedule 2 to this Order.
- (c) The deletions from Schedule 3 of the Order of 1979 of the lengths of road specified in Schedule 3 to this Order.
- (d) The deletions from Schedule 5 of the Order of 1979 of the lengths of road specified in Schedule 4 to this Order.
- (e) The deletion from Schedule 17 of the Order of 1979 of the lengths of road specified in Schedule 5 to this Order.
- (f) The additions to Schedule 1 of the Order of 1979 of the lengths of road specified in Schedule 6 to this Order

1(2) The Wiltshire County Council (Salisbury) (East Street/West Street Area) (Residents Parking Places) Order 1992 is hereby revoked.

Commencement and Citation

- 2. This Order shall come into operation on the 3rd day of June 1997 and may be cited as the Wiltshire County Council (Salisbury - Zone B) (Waiting Restrictions and Residents Parking Bays) Order 1997.

Interpretation

3(1) In this Order:-

"access way" means a space in a parking place which is provided to enable a vehicle to have access to and egress from premises adjacent to the parking place.

"car parking inspector" means a person employed by the Wiltshire County Council or the Salisbury District Council for the control of the parking of vehicles in public parking places in that District in accordance with the regulations in force for those parking places.

"the Council" means during any period in which there is in force an agreement under Section 113 of the Local Government Act 1972 between the Wiltshire County Council and the Salisbury District Council that officers of the District Council shall administer the Order on the County Council's behalf, the Salisbury District Council; failing which it shall mean the Wiltshire County Council.

"driver" in relation to a vehicle waiting in a parking place, means the person driving the vehicle at the time it was left in the parking place.

"goods" includes postal packets of any description.

"delivering" and "collecting" in relation to any goods include checking the goods for the purpose of their delivery or collection.

"goods vehicle" means a motor vehicle which is constructed or adapted for use for the carriage of goods or burden of any description and which has a Gross Vehicle Weight not exceeding 2 tonnes and is not drawing a trailer.

"dual purpose vehicle" has the same meaning as in Regulation 3 of the Road Vehicles (Construction and Use) Regulations 1986.

"motor cycle" and "invalid carriage" have the same meaning as in Sections 136(4) and 136(5) respectively of the Act.

"Disabled Person's Vehicle" means a vehicle lawfully displaying a disabled person's badge.

"Disabled Person's Badge" means any badge issued, or having the effect as if issued under any regulations for the time being in force under Section 21 of the Chronically Sick and Disabled Persons Act 1970.

"loading bay" means a space in a parking place which is provided for the waiting of a vehicle for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle at premises adjacent to the parking place.

"owner" in relation to a vehicle means the person by whom such vehicle is kept and used.

"one-way street" means a highway in which vehicles are prohibited at all times from proceeding in any other than one direction.

"parking space" means a space in a parking place which is provided for the leaving of a vehicle.

"parking place" means an area on a highway designated as a parking place by Article 8 of this Order.

"passenger vehicle" means a motor vehicle (other than a motor cycle or invalid carriage) constructed solely for the carriage of passengers and their effects and adapted to carry not more than twelve passengers exclusive of the driver and not drawing a trailer.

"permit" means a permit issued under the provisions of Article 11 of this Order.

"permit holder" means a person to whom a permit has been issued under the provisions of Article 11 of this Order.

"permitted hours" means the period between 9.00 a.m. and 5.00 p.m. on Monday to Saturday inclusive but excluding any such day that is Christmas Day or a Bank Holiday.

"resident" means a person whose usual residence is at premises the postal address of which is in any street or part of a street described in Schedule 12 to this Order.

"telecommunications apparatus" has the same meaning as in Schedule 2 of the Telecommunications Act 1984.

"household" means a collective group of related domestic residents whose usual residence is at one dwelling, the address of which or the flank frontage of which is in any street or part of a street described in Schedule 12 to this Order.

"traffic sign" means a sign of any size, colour and type prescribed or authorised under, or having effect as though prescribed or authorised under, Section 64 of the Act.

- 3(2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

Waiting Restrictions

4. Save as provided in Articles 29, 30 and 31 of this Order, no person shall except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden, cause or permit any vehicle to wait in any of the lengths of road specified in Schedule 7 to this Order.
5. Save as provided in Articles 29, 30 and 31 of this Order, no person shall except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden, cause or permit any vehicle to wait between the hours of 8.00 a.m. and

6.00 p.m. Monday to Saturday in any of the lengths of road specified in Schedule 8 to this Order.

6. Save as directed in Articles 29, 30 and 31 of this Order, no person shall except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden cause or permit any vehicle to wait between the hours of 8.00 a.m. and 7.00 p.m. Monday to Saturday in any of the lengths of road specified in Schedule 9 to this Order.
7. Save as directed in Articles 29, 30 and 31 of this Order, no person shall except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden cause or permit any vehicle to wait between the hours of 8.00 a.m. and 7.00 p.m. Monday to Saturday for a longer period than 30 minutes or if a period of less than 30 minutes has elapsed since the termination during the said hours of the last period of waiting of the vehicle in that length of road specified in Schedule 10 to this Order.

Designation of Parking Places

8. Each area on a highway which is described as a designated parking place in Schedule 11 to this Order is designated as a parking place.

Use of Parking Places

9. Save as provided in Articles 10, 20, 26 and 28 to this Order, no person shall except upon the direction or with the permission of a car parking inspector, cause or permit any vehicle to wait during the permitted hours in any of the lengths of roads specified in Schedule 11 to this Order for a longer period than two hours, or if a period of less than four hours has elapsed since a previous period of waiting by the same vehicle in the same length of road.
10. Nothing in Article 9 to this Order shall prevent the leaving during the permitted hours of a vehicle bearing a valid permit issued and displayed in accordance with the provisions of this Order for a period longer than two hours in any of the lengths of road specified in Schedule 11 to this Order.

Application for and Issue of Permits

11. (1) Resident's Permit

Any domestic resident who is the owner of a passenger vehicle, a dual purpose vehicle, a goods vehicle or a motor cycle, may apply to the Council for the issue of a permit for the leaving in a designated parking place of that vehicle and any such application shall be made on a form issued by and obtainable from the Council and shall include the information required by such form.

(2) Visitor's Permit

- (i) Any domestic resident whose usual residence is at a premises, the postal address of which is in any street or part of a street described in Schedule 12 to this Order, may apply for a visitor's permit for use on any passenger vehicle, dual purpose vehicle, goods vehicle or motor cycle belonging to any visitor to the household, for the leaving of that vehicle in a designated parking place. Such application shall be made on a form issued by and obtainable from the Council and shall include the information required by such form.
 - (ii) A maximum of two permits per household may be applied for at any time.
 - (iii) A visitor's permit shall be valid from the dates as requested on the application and as shown on the permit, up to a maximum of one month.
 - (iv) Any domestic resident over sixty years of age living in a household to whom no permit has been issued, may apply to the Council for the issue of a visitor's permit for use on any passenger vehicle, dual purpose vehicle, goods vehicle or motor cycle belonging to any visitor to the household for the leaving in a designated parking place of that vehicle and such application shall be made on a form issued by and obtainable from the Council and shall include the information required by such form. Such permits shall be valid for a period of one year. Any domestic residents over sixty years of age may also apply for a short-term visitor's permit in accordance with Article 11(2)(i).
- (3) The Council may at any time require an application for a permit to produce to an officer of the Council such evidence in respect of an application for a permit made to them as they may reasonably require to verify any information given to them, or in respect of any permit issued by them as they may reasonably require to verify that the permit is valid.
- (4) On receipt of an application made under the foregoing provisions of this Article, the Council, upon being satisfied that the applicant is:-
- (a) a domestic resident and is the owner of a vehicle of the class specified in paragraph (1) of this Article shall issue to that applicant one permit for the leaving during the permitted hours in a parking space in any parking place of the vehicle to which such permit relates by the owner of such vehicle or by any person using such vehicle with the consent of the owner other than a person to whom such vehicle has been let for hire or reward, or
 - (b) a domestic resident over sixty years of age and is living in a household to whom no permit has been issued, shall issue to that applicant one visitor's permit for use by any visitor to that household for the leaving

during the permitted hours in a parking space in a parking place of a vehicle of the class specified in paragraph (2) of this Article.

- (c) a domestic resident who does not hold more than one valid visitor's parking permit in accordance with Article 11(2), shall issue to that applicant one permit (or in the case of a domestic resident holding no visitors' permits a maximum of two permits) for the leaving during the permitted hours in a parking space in any parking place, of the vehicle to which such permit relates.

Provided that, subject to the provisions of Article 13 of this Order, the Council shall not issue any permit to a resident which would be valid for any period during which any other permit issued to that resident extends.

Surrender, Withdrawal and Validity of Permits

- 12. (1) A permit holder may surrender a permit to the Council at any time and shall surrender a permit to the Council on the occurrence of any of the events set out in paragraph (3) of this Article.
- (2) The Council may, by notice in writing served on the permit holder at the address shown by that person on the application for the permit or at any other address believed to be that person's residence, withdraw a permit if it appears to the Council that any one of the events set out in paragraph 3(a), (b) or (c) of this Article has occurred and the permit holder shall surrender the permit to the Council within 48 hours of the receipt of such notice.
- (3) The events referred to in the foregoing provisions of this Article are:-
 - (a) the permit holder ceasing to be a resident;
 - (b) the permit holder ceasing to be the owner of the vehicle in respect of which the permit was issued;
 - (c) the vehicle in respect of which such permit was issued being adapted or used in such manner that it is not a vehicle of the class specified in Article 11 of this Order;
 - (d) a visitor's permit shall cease to be valid and must be surrendered at the time an application is made for a resident's permit by any member of the visitor's permit holder's household;
 - (e) the issue of a duplicate permit by the Council under the provisions of Article 13 of this Order;
 - (f) the withdrawal or cancellation of the permit by the Council.

- (4) A permit shall cease to be valid at the expiration of the period specified thereon or on the occurrence of any one of the events set out in paragraph (3) of this Article, whichever is the earlier.
- (5) The Council may at any time require a permit holder to produce to an officer of the Council such evidence in respect of any permit issued by them as they may reasonably require.

Application for and Issue of Duplicate Permits

13. (1) If a permit is mutilated or defaced or the figures or particulars on it have become illegible or the colour of the permit has become altered by fading or otherwise, the permit holder shall surrender it to the Council and may apply to the Council for the issue to him of a duplicate permit and the Council, upon the receipt of the permit shall issue a duplicate permit so marked.
- (2) If a permit is lost or destroyed, the permit holder may apply to the Council for the issue to him of a duplicate permit and the Council, upon being satisfied as to such loss or destruction, shall issue a duplicate permit so marked.
- (3) The provisions of this Order shall apply to a duplicate permit and an application for a duplicate permit as if it were an initial application for a permit.

Form of Permits

14. A permit shall be in indelible writing and shall include the following particulars:-

(A) For a Resident's Permit

- (a) the permit number;
- (b) an indication of the zone for which the permit has been issued;
- (c) the registration mark of the vehicle in respect of which the permit has been issued;
- (d) the period during which, subject to Article 12(4) of this Order, the permit shall remain valid;
- (e) an authentication that the permit has been issued by the Council.

(B) For a Visitor's Permit

- (a) the permit number;
- (b) an indication of the zone for which the permit has been issued;

- (c) the address of the householder;
- (d) the period during which, subject to Article 12(4) of this Order, the permit shall remain valid;
- (e) an authentication that the permit has been issued by the Council.
- (f) the vehicle registration number (except in the case of visitors' permits issued to domestic residents over sixty years of age).

Amount of Charge at Parking Places

15. (1) Save as provided in paragraph (2) of this Article there shall be a charge of £20 per day or part of a day in respect of any vehicle left in a parking place during the permitted hours.
- (2) A vehicle left in a parking place in accordance with the provisions of either Article 9 or 10 of this Order shall be exempt from the charge specified in paragraph (1) of this Article.
- (3) In the case of a vehicle in respect of which a parking charge may have been incurred, it shall be the duty of a car parking inspector to attach to the vehicle in a conspicuous position a notice which shall include the following particulars:-
- (a) the registration mark of the vehicle or, where the vehicle being used has a trade licence, the number of the trade plate carried on the vehicle;
 - (b) the time at which he first noticed that an offence had been committed;
 - (c) a statement that a parking charge of £20 is required to be paid.

Restriction on Removal of Parking Charge Notices

16. Where a notice has been attached to a vehicle in accordance with the provisions of Paragraph (3) of Article 15 of this Order, no person, not being the driver of the vehicle or duly authorised representative of the Council, shall remove the notice from the vehicle unless authorised to do so by the driver.

Manner of Payment of Parking Charges

17. The parking charge shall be paid to the Council either by cheque, bankers' draft, money order or postal order which shall be made payable to the Salisbury District Council, and crossed "Lloyds Bank plc", and shall be delivered or sent by post so as to reach the Council's Treasurer at 18 Pennyfarthing Street, Salisbury, not later than 4.30 p.m. on the fourteenth day following the day on which the parking charge was incurred or in cash in person at the said offices not later than aforesaid.

Provided that, if the said fourteenth day falls upon a day on which the said offices are closed, the period within which payment of the said charge shall be made to the council

shall be extended until 4.30 p.m. on the next full day on which the said offices are open.

Display of Permits

18. At all times during which a vehicle is left in a parking place during the permitted hours there shall be displayed on the front or near-side of the vehicle a permit issued in respect of that vehicle so that all the particulars referred to in Article 14 of this Order are readily visible from the front or near-side of the vehicle.

Restriction on the Removal of Permits and Notices

19. Where a permit has been displayed on a vehicle in accordance with the provisions of Article 18 of this Order, no person, not being the driver of the vehicle, shall remove the permit from the vehicle unless authorised to do so by the driver of the vehicle.

Exemptions for Disabled Drivers

20. (1) Notwithstanding the provisions of Articles 9, 10 and 15 of this Order the following vehicles may be left during the permitted hours in a parking space, and any such vehicle shall be exempt from the payment of any charge specified in this Order:-
- (a) an invalid carriage;
 - (b) a vehicle issued to a disabled person by the Department of Health & Social Security in lieu of an invalid carriage;
 - (c) a disabled person's vehicle which displays in the relevant position a disabled person's badge issued by any local authority in accordance with the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 1982 and for the purpose of this sub-paragraph a badge shall be in the relevant position if:
 - (i) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the near side of and immediately behind the windscreen; and
 - (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the vehicle.
- (2) A vehicle which is so exempt shall stand in the parking place in accordance with the provisions of Article 22(a) and (b) of this Order and wholly within the limits of that space.

Placing of Traffic Signs

21. The Council shall:-

- (a) cause the limits of each parking place to be indicated on the carriageway by placing and maintaining thereon the appropriate traffic signs;
- (b) place and maintain on or in the vicinity of each parking place appropriate traffic signs for indicating that such parking place may be used during the permitted hours for the leaving only of the vehicles specified in Article 10 of this Order; and
- (c) carry out such other work as is reasonably required for the purposes of the satisfactory operation of a parking place.

Manner of Standing in Parking Places

22. Every vehicle left in a parking place in accordance with the provisions of this Order shall so stand:-

- (a) that the longitudinal axis of the vehicle is parallel to the edge of the carriageway nearest to the vehicle and the distance between the said edge and the nearest wheel of the vehicle is not more than 30 centimetres;
- (b) that every part of the vehicle is within the limits of the parking places.

Provided that no vehicle may, by virtue of Article 10 or of this Article, wait in any part of a parking place which is an access way or a loading bay.

Alteration of Position of Vehicle in Parking Places

23. Where any vehicle is standing in a parking place in contravention of the provisions contained in Article 22 or 28 of this Order a car parking inspector may alter or cause to be altered, the position of the vehicle in order that its positions shall comply with those provisions.

Removal of Vehicles from Parking Places

24. Where a car parking inspector is of the opinion that any of the provisions contained in Article 28(2) of this Order have been contravened or not complied with in respect of a vehicle left in a parking place, he may remove or cause to be removed the vehicle from the parking place, and where it is so removed, shall provide for the safe custody of the vehicle.

Movement of Vehicles in Parking Places in Emergencies

25. A police officer in uniform, a traffic warden or a car parking inspector may, in case of emergency, move or cause to be moved any vehicle left in a parking place to any place he thinks fit.

Power to Suspend use of Parking Places

26. (1) Any person authorised by the Council may suspend the use of a parking place or any part thereof whenever the Council considers such suspension reasonably necessary:-
- (a) for the purpose of facilitating the movement of traffic or promoting its safety;
 - (b) for the purpose of any building operation, demolition or excavation in or adjacent to the parking place or the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration, removal or repair in or adjacent to the parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunication apparatus or traffic sign;
 - (c) for the convenience of occupiers of premises adjacent to the parking place on any occasion of the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository;
 - (d) on any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed; or
 - (e) for the convenience of occupiers of premises adjacent to the parking place at times of weddings or funerals, or on other special occasions.
- (2) A police officer in uniform may suspend for not longer than twenty four hours the use of a parking place or any part thereof whenever he considers such suspension reasonably necessary for the purpose of facilitating the movement of traffic or promoting its safety.
- (3) Any person suspending the use of a parking place or any part thereof in accordance with the provisions of paragraph (1) or paragraph (2) of this Article shall thereupon place or cause to be placed in or adjacent to that parking place or the part thereof the use of which is suspended a traffic sign indicating that waiting by vehicles is prohibited.
- (4) No person shall cause or permit a vehicle to be left in any parking place or part of a parking place during such period as there is in or adjacent to that parking place or part of a parking place a traffic sign in pursuance of paragraph (3) of this Article:

Provided that nothing in this paragraph shall render it unlawful to cause or permit a vehicle to be left in a car parking place if it is being used:

- (a) for fire brigade, ambulance or police purposes, or by a local authority in pursuance of its statutory powers and duties;
- (b) in connection with the removal of any obstruction to traffic;
- (c) being used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953; or
- (d) is in the service of or employed by British Telecom in connection with the servicing of telephone kiosks adjacent to the parking place; or
- (e) if the vehicle is left with the permission of the person suspending the use of the parking place, a police officer in uniform, a traffic warden or a car parking inspector.

Restriction of Use of Vehicles at Parking Places

27. While any vehicle is in a parking place during the permitted hours, no person shall use the vehicle in connection with the sale of any article to any person in or near the parking place or in connection with the selling or offering for sale of his skill or services:

Provided that nothing in this Article shall prevent the sale of goods from a vehicle:-

- (a) if the vehicle is a passenger vehicle, a dual purpose vehicle, a goods vehicle or a motor cycle (or an invalid carriage) and the goods are immediately delivered at or taken into premises adjacent to the vehicle from which the sale is affected; or
- (b) if the vehicle is one to which the provisions of Article 28(1)(e) of this Order apply.

Restriction of Waiting of Vehicles in Parking Places

28. (1) Notwithstanding the foregoing provisions of this Order, any vehicle may wait during the permitted hours anywhere on the carriageway in a parking place (other than a parking place or part of a parking place the use of which has been suspended, under Article 26 of this Order) for so long as may be necessary if:-
- (a) the vehicle is a vehicle used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service of a local authority which is being used in pursuance of statutory powers or duties;
 - (b) the vehicle is waiting to enable it to be used in connection with the removal of any obstruction to traffic;

- (c) the vehicle (not being a passenger vehicle) is waiting to enable it to be used for any purpose specified in Article 26(1)(b) of this Order.
 - (d) the vehicle (not being a passenger vehicle) is in actual use in connection with the removal of furniture from one business or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository;
 - (e) the vehicle is waiting otherwise than in a parking space if goods are being sold or offered for sale from the vehicle by a person who is licensed by the Council to sell goods from a stationary pitch situated in the parking place.
- (2) Except as provided in the foregoing provisions of this Article, and in the provisions of Articles 9, 10 and 26(4) of this Order the driver of a vehicle shall not cause or permit the vehicle to wait in a parking place during the permitted hours.
 - (3) Nothing in the foregoing provisions of this Article shall be taken as authorising anything which would be a contravention of any regulations made or having effect as if made under Section 25 of the Act.

Exceptions to Waiting Prohibitions

29. Nothing in Articles 4, 5, 6, 7, 8 and 9 of this Order shall prevent any person from causing or permitting a vehicle to wait in any of the lengths of road referred to in those Articles for so long as may be necessary:-

- (1) to enable a person to board or alight from the vehicle;
- (2) to enable goods to be loaded on to or unloaded from the vehicle;
- (3) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road so referred to or the laying, erection, alteration or repair in or near to any of the said lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraphic line as defined in the Telegraph Act 1878;
- (4) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers or duties;
- (5) to enable the vehicle to take in petrol, oil, water or air from any garage situated in or adjacent to the said length of road; or
- (6) to enable a vehicle to be loaded or unloaded whilst it is in actual use in connection with the removal of furniture and effects from one office or

dwellinghouse to another or to such premises from a depository or from such premises to a depository provided notice is given twenty four hours in advance to the police, their consent is obtained and such reasonable conditions as they may impose are complied with.

31. Nothing in Articles 4, 5, 6, 7, 8 and 9 of this Order shall apply to any vehicle:-

- (a) being used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953; or
- (b) owned by a funeral director or owner of funeral vehicles when used as part of a funeral cortege or otherwise in connection with a funeral.

32. Nothing in Articles 4, 5, 6, 7, 8 and 9 of this Order shall prevent any person from causing or permitting a vehicle to wait in any of the lengths of road referred to in those Articles for so long as may be necessary to enable the vehicle if it cannot conveniently be used for such purpose in any other road to be used in connection with the attendance of any medical practitioner on his or her patients or at his or her surgery.

SCHEDULE 1

(Deletions from Schedule 1 of the Order of 1979)

(Prohibition of Waiting at All Times)

Fisherton Street	North East	From its junction with Bridge Street to the north west side of the Railway Bridge.
	South West	From a point 52 metres north west of the western abutment of Fisherton Bridge to the west side of the railway bridge.

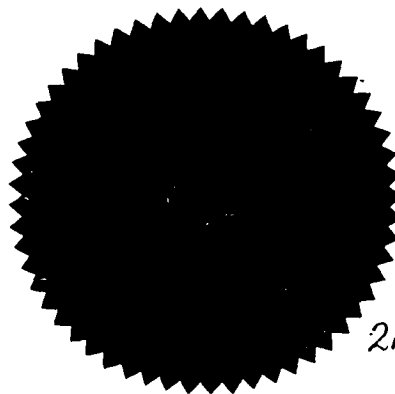
