**THE A36 TRUNK ROAD (SOUTHAMPTON ROAD, SALISBURY)
(PROHIBITION OF VARIOUS TRAFFIC MOVEMENTS, WAITING AND
LOADING) ORDER 2000**

Made 18 April 2000

Coming into force 21 April 2000

WHEREAS the Secretary of State for the Environment, Transport and the Regions, in exercise of the powers conferred by sections 1(1), 2(1) and (2) and 4(1) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic regulation Act 1984(a) and of all others enabling him in that behalf, hereby makes the following Order: -

1. This Order may be cited as the A36 Trunk Road (Southampton Road, Salisbury) (Prohibition of Various Traffic Movements, Waiting and Loading) Order 2000 and shall come into force on 21 April 2000.

2. In this Order:

"the trunk road"

means the A36 trunk road, Southampton Road, Salisbury, from a point 5 metres west of the western side of its junction with Tollgate Road to a point 140 metres west of the western edge of its roundabout junction with Bourne way;

"a bus"	means a vehicle used to provide a local service;
"a local service"	has the meaning given in section 2 of the Transport Act 1985(a);
"a bus stop area"	means an area of carriageway comprised in the trunk road which is intended for the waiting of buses, and is comprised within and indicated by a road marking complying with diagrams 1025.1 and 1025.2 in Schedule 6 to the Traffic Signs and Regulations and General Directions 1994(b),

and a reference to an article followed by a number is a reference to an article in this Order which bears that number.

3. Save as provided in article 4, no person shall cause or permit any vehicle -
 - (a) proceeding eastwards in the trunk road to turn right into any road or access to premises;
 - (b) proceeding westwards in the trunk road to turn right into any road or access to premises;
 - (c) on entering the trunk road from any road or access, except Tollgate Road, to proceed in any direction other than leftwards;
 - (d) except buses, on entering the trunk road from Tollgate Road, to proceed in any direction other than leftwards; and
 - (e) to 'U' turn from the westbound carriageway to the eastbound carriageway, or from the eastbound carriageway to the westbound carriageway, of the trunk road at its junction with Tollgate Road.
4. The provisions of article 3 shall not apply to -
 - (a) any vehicle being used for police, ambulance or fire brigade purposes; or
 - (b) anything done at the direction of, or with the permission of, a police constable in uniform or a traffic warden

5. Save as provided in article 6, no person shall, except upon the direction of, or with the permission of, a police constable in uniform or of a traffic warden, cause or permit any vehicle to wait at any time on either side of the A36 trunk road, Southampton Road, Salisbury, from a point 100 metres east of its junction with Tollgate Road to the western edge of its roundabout junction with Bourne Way.

6. Nothing in article 5 shall apply:

- (a) in relation to a bus waiting at any time in a bus stop area;
- (b) so as to prevent a vehicle waiting on a side of the trunk road specified in the Schedule for so long as may be necessary for it to be used in connection with -
 - (i) the removal of any obstruction to traffic,
 - (ii) any building, operation or demolition,
 - (iii) the maintenance, improvement or reconstruction of the trunk road, or
 - (iv) the laying, erection, inspection, maintenance, alteration, repair, renewal or removal in or near the trunk road of any sewer, main, pipe conduit, wire, cable or other apparatus for the supply of gas, water, electricity or any telecommunications apparatus as defined in Schedule 2 to the telecommunications Act 1984(a);
- (c) in relation to a vehicle being used -
 - (i) for fire brigade, ambulance or police purposes,
 - (ii) in the service of a local authority in pursuance of statutory powers or duties,
 - (iii) in the service of a water or sewerage undertaker within the meaning of the Water Industry Act 1991(b), or

7. No person shall, except upon the direction of, or permission of, a police constable in uniform or of a traffic warden, cause or permit any vehicle to wait on either side of the A36 trunk road, Southampton Road, Salisbury, from the eastern edge of its roundabout junction with Churchill Way to the western edge of its roundabout junction with Bourne Way to load or unload goods from that vehicle.

8. The A36 Trunk Road (Southampton Road, Salisbury) (Prohibition of Various Traffic Movements, Waiting and Loading) (Experimental) Order 1998 is hereby revoked.
